Describe Cause of Problem and Remedial Action Taken.*

The new flow line was being installed (from 1/29/2009 rupture). The well was put back into production after being told new line was ready for service. It was discovered that one weld was not complete leaving line open ended and causing release. Vacuum truck and backhoe crew called.

Describe Area Affected and Cleanup Action Taken.*

An approximate area of 20' X 20'. The flow line was repaired and remaining oil and produced water recovered. Impacted soils were excavated and hauled to an NMOCD approved facility. Vertical and horizontal delineation samples will be taken and analysis ran for TPH & BTEX. Chlorides will be documented. Depth to Ground Water: >100' (approximately 184'), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0. Based on recovered amounts of oil & produces water, soils excavated/removed and enclosed analytical results, Yates Petroleum Corporation requests closure.
