Chevron U.S.A. Inc. respectfully requests administrative approval for simultaneous dedication of the Eunice King # 8 with the Eunice King # 13 and # 14 in the Tubb Oil and Gas Pool.

Chevron is planning to recomplete the Eunice King # 8 as a gas well in the Tubb formation. The subject well was originally drilled and completed as an oil producer in the Drinkard formation in 1948. The well has produced from the Drinkard (1948-61), Blinebry (1961-87), Paddock (1988-92), and Blinebry (1992-present) formations during its history. Currently, Eunice King # 8 is a shut-in marginal producer in the Blinebry, with a last test of 1 BOPD, 3 BWPD, and 20 MCFPD. In order to return the well to economic production it is proposed to recomplete as a gas producer in the Tubb formation.

Eunice King # 13 and # 14 are currently simultaneously dedicated to a standard 160acre Tubb Gas Proration Unit consisting of the NE ¼ of Section 28, T21S, R37E. Eunice King # 13 is located 554' FNL & 554' FEL of Section 28 and Eunice King # 14 is located 1874' FNL & 2086' FEL of Section 28. The simultaneous dedication of these two unorthodox gas well locations to a 160-acre standard Tubb Gas Proration Unit were authorized by the NMOCD on March 17, 1999 under Administrative Order NSL-4234 (SD).

Chevron U.S.A. Inc. respectfully requests administrative approval to simultaneously dedicate Tubb Oil and Gas Pool production from Eunice King # 8, #13, and #14 to a

standard 160-acre gas proration unit consisting of the NE ¼ of Section 28, T21S, R37E, Lea County, New Mexico.



Dear Mr. Bohling:

Reference is made to your application dated February 18, 1999, which was received by the New Mexico Oil Conservation Division ("Division") in Santa Fe on February 25, 1999, for an unorthodox Tubb gas well location within an existing standard 160-acre gas spacing and proration unit ("GPU") for the Tubb Oil and Gas Pool comprising the NE/4 of Section 28, Township 21 South, Range 37 East, NMPM, Lea County, New Mexico. This GPU is currently dedicated to Chevron U.S.A. Inc.'s Eunice King Well No. 13 (API No. 30-025-06849) located at an unorthodox gas well location 554 feet from the North and East lines (Unit A) of Section 28, which was "grandfathered" in as a standard Tubb gas well location for the subject 160-acre GPU pursuant to Rule 2 of the "Special Rules and Regulations for the Tubb Gas Pool," as promulgated by Division Order No. R-586, issued in Case No. 728 dated April 11, 1955.

It is our understanding that the subject well in this application, the Eunice King Well No. 14 (API No. 30-025-06851), was originally drilled by Gulf Oil Corporation in 1949 to a total depth of 7,665 feet and completed in the Hare-Simpson Pool at a standard oil well location 1874 feet from the North line and 2086 feet from the East line (Unit G) of Section 28. In 1990 Chevron recompleted this well as an oil well into the Blinebry Oil and Gas Pool. It is further understood that Chevron now intends to recomplete this well up-hole into the Tubb Oil and Gas Pool.

Pursuant to Rule 2(b)1 of the "General Rules for the Prorated Gas Pools of New Mexico/Special Rules and Regulations for the Tubb Oil and Gas Pool," as promulgated by Division Order No. R-8170, as amended, the location of the Eunice King Well No. 14 is considered to be unorthodox.

By authority granted me under the provisions of Rule 2(d) of the special rules for the Tubb Oil and Gas Pool, the unorthodox location of the Eunice King Well No. 14 is hereby approved.

Also, you are hereby authorized to simultaneously dedicate Tubb gas production from the Eunice King Well No. 14 with the Eunice King Well No. 13. Furthermore, you are hereby

permitted to produce the allowable assigned the subject 160-acre GPU from both wells in any proportion.
