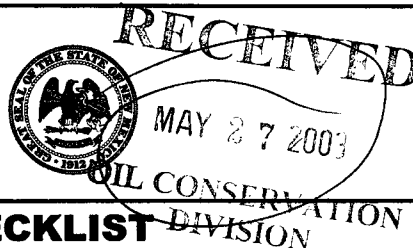

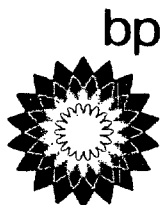

BP America Production Company respectfully requests an administrative approval for a non-standard well location for the McEwen Gas Com D Well No. 1S to be drilled at a location of 580' FNL & 540' FWL of Section 05-T31N-R10W. The non-standard location is necessitated by topographical conditions and would insure the conservation of surface and subsurface resources in the area. Topographical obstructions within the legal drilling area are sever terrain - rough sloping terrain (side of cliff), County Road 2900, the wet lands next to Animas River, an irrigation ditch and the location of existing buildings.

To aid in your review is attached a C-102 Well Location Plat showing the well location, a topographical map (APD Map # 1), a 9 section plat showing the offset wells and a field review of other locations.

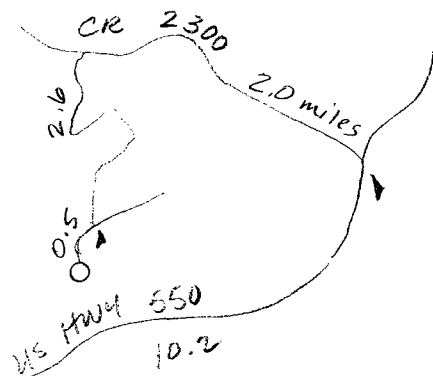

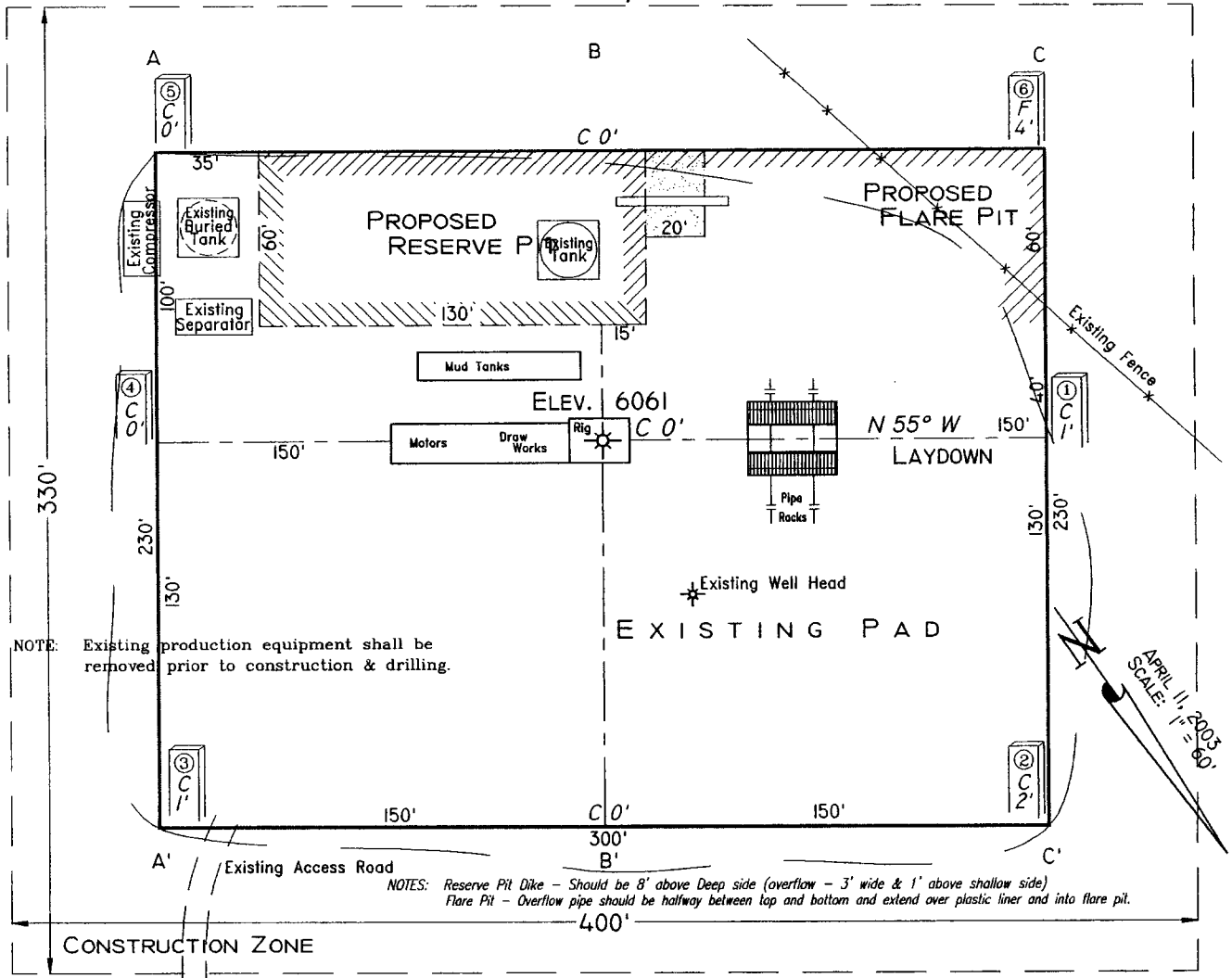

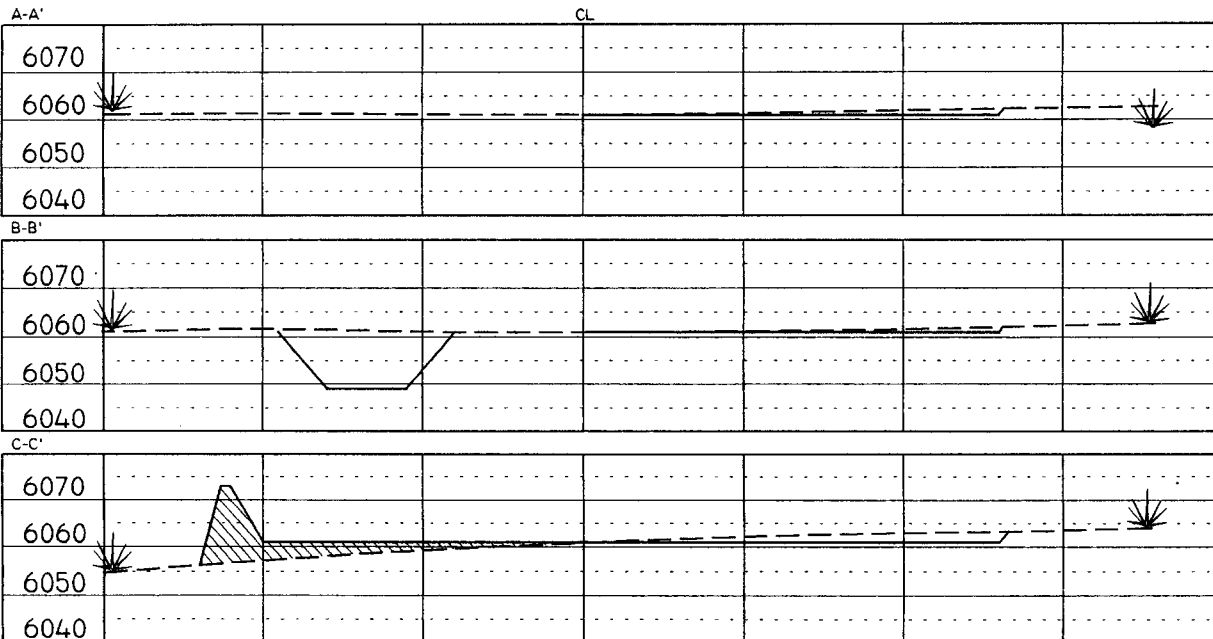

Area of Construction Zone - 330'x400' or 3.03 acres, more or less.

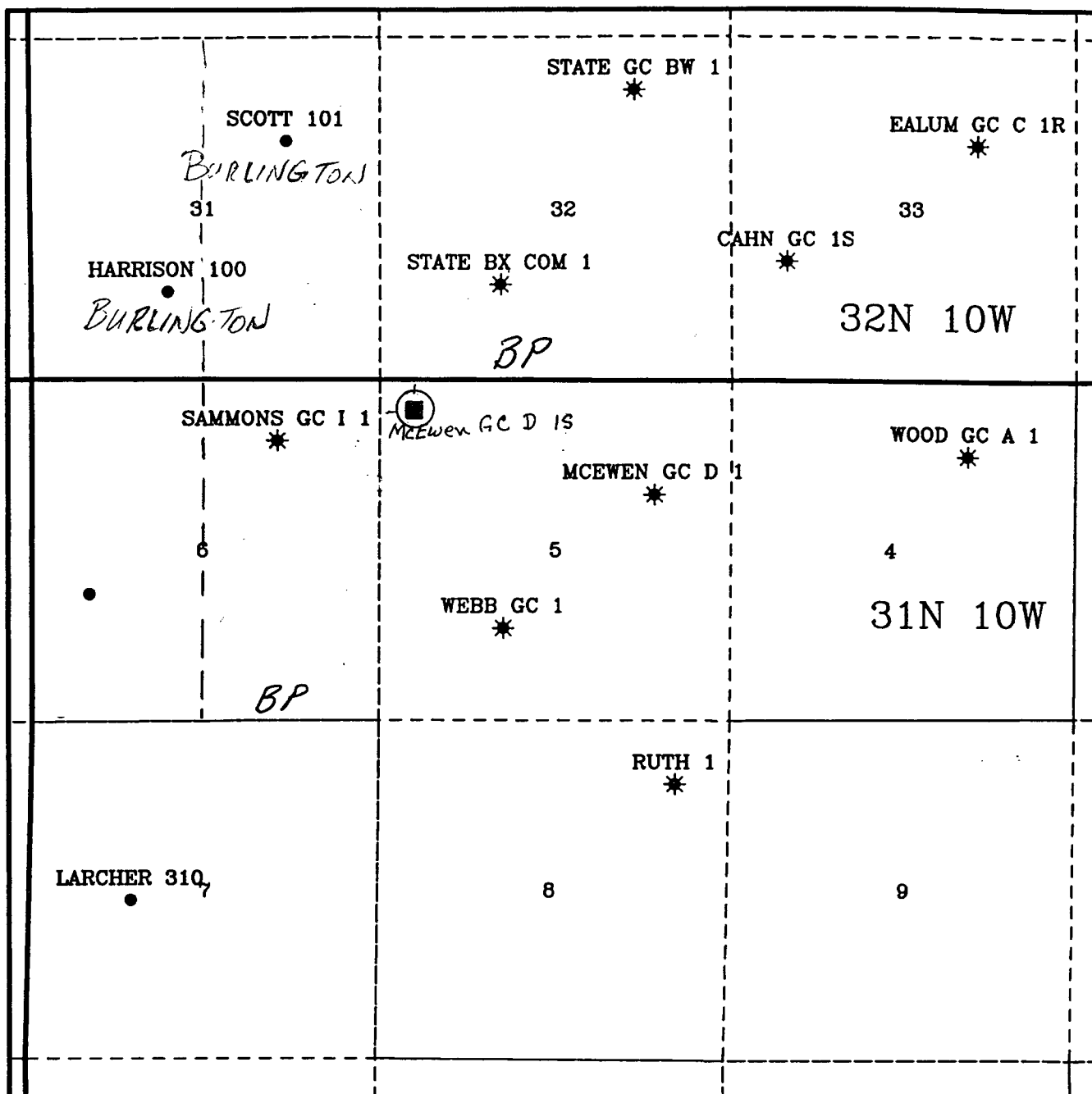

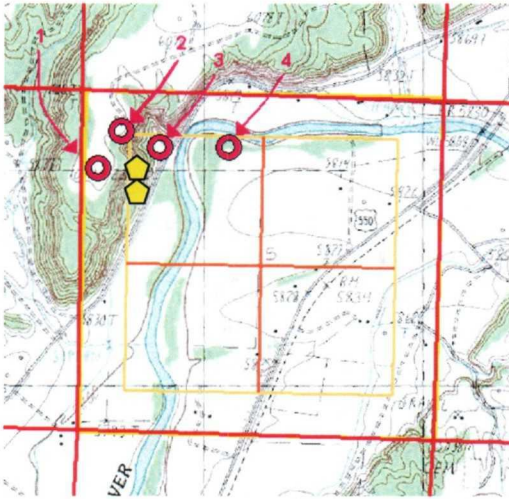

Houses

Location #1 (withdrawn 3/4/03)

Location too close to section line. The well could be directionally drilled 410' to the east. However, high mechanical risks.

Location #2 (Current Location)

Still an orthodox location. The well could be drilled in this location with non or very small implications. The location is very close to the McEwen A-1 location, reducing in this way soil disturbance. Roads to the location are in place and production pipes will be shorter than for alternate locations.

Location#3

Location in very steep terrain. About a 100' drop off. Soil erosion issues.

Location #4

Located in wet lands, next to Animas river. Not an option.
