Mr. Hansen:

Rice Operating Company (ROC) is the service provider (agent) for the EME Saltwater Disposal (SWD) System and has no ownership of any portion of the pipeline, well, or facility. The System is owned by a consortium of oil producers, System Parties, who provide all operating capital on a percentage ownership/usage basis.

Background

In 2010, ROC initiated work on the former P-20 junction box. The site is located in UL/P, Sec. 20, T19S, R37E. NM OSE records indicate that groundwater would likely be encountered at a depth of approximately 30 +/- feet. The site was delineated using a backhoe to collect soil samples at regular intervals, creating a 5x3x9 ft deep excavation. Each sample was field titrated for chlorides and field screened using a PID for hydrocarbons, resulting in low concentrations of each. The 9 ft sample was sent to a commercial laboratory for analysis of chloride and TPH, resulting in a chloride, gasoline range organics (GRO) and diesel range organics (DRO) concentration below detectable limits. The excavated soil was returned to the excavation and contoured to the surrounding area. On 5/21/2010, the site was seeded with a blend of native vegetation. A junction box is no longer needed at the site. Vegetation has rebounded at the site, so no re-vegetation efforts are needed.

The junction box site location map, final report, photodocumentation, laboratory analysis, PID sheet, chloride graph and current photodocumentation are attached.

Recommendations

Site investigation demonstrates that residual chloride and hydrocarbons in the vadose zone will not with reasonable probability contaminate groundwater in excess of NMOCD standards. This site meets the requirements of the NMOCD-approved Revised Junction Box Upgrade Work Plan (July 16, 2003). As such, ROC request termination of the regulatory file, or similar closure status.

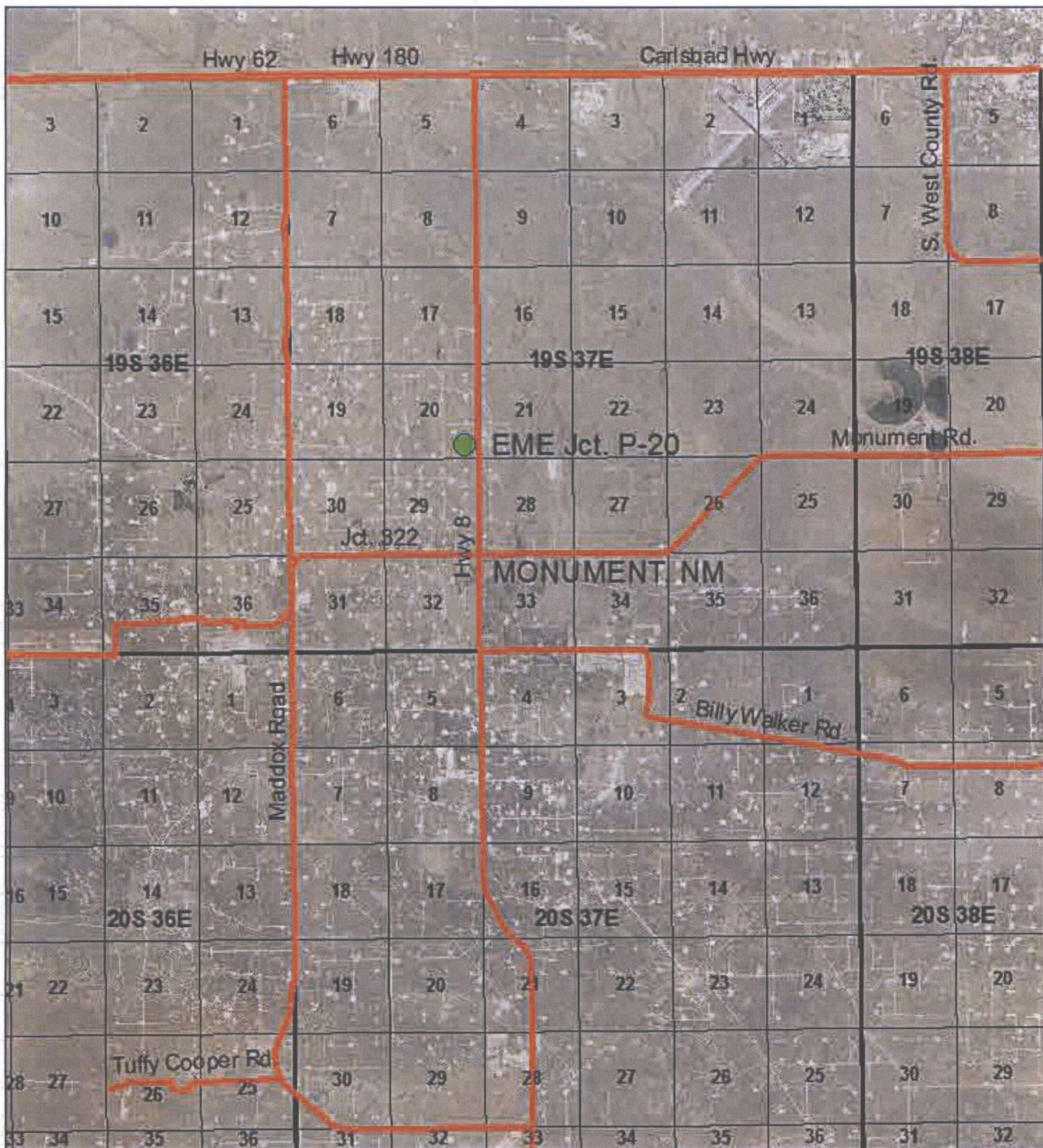

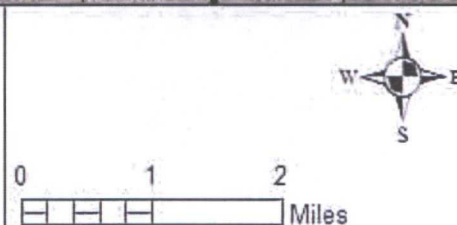
Site Location Map

General Description of Remedial Action: This junction and line were eliminated

during the pipeline replacement/upgrade program. After the former junction box was

removed, an investigation was conducted using a backhoe to collect soil samples at

regular intervals producing a 5X3X9-ft. deep excavation. Chloride field test performed

on each sample yielded low concentrations similar to the background. Organic vapors

were measured using a PID, which also yielded low concentrations. The deepest sample, 9 ft. BGS was sent to a commercial laboratory

for analysis of chloride and TPH, which confirmed low concentrations. The excavated soil was returned to the excavation to ground

surface and contoured to the surrounding area. On 5/21/2010, the site was seeded with a blend of native vegetation and is expected to

return to a productive capacity at a normal rate.

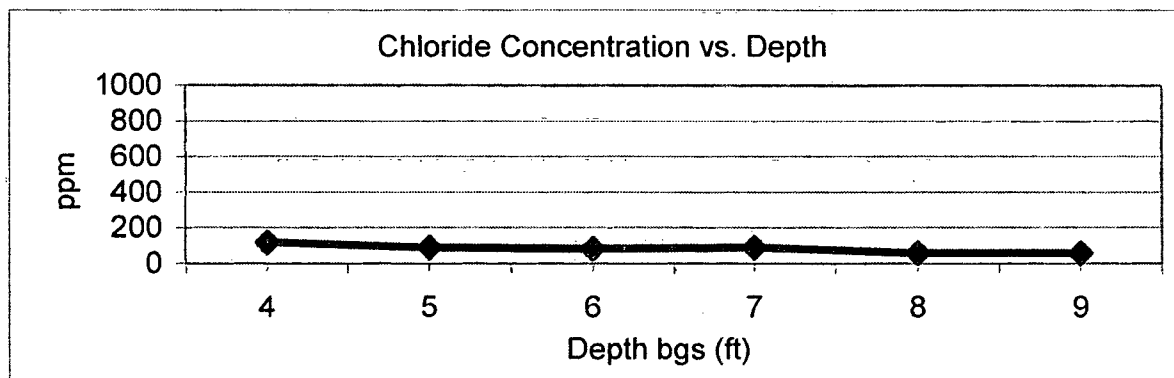
