You have requested to re-complete this well at an unorthodox oil well location described above, in the referenced pool or formation. This location is less than 330 feet from a unit boundary.

Your application has been duly filed under the provisions of Division Rules 15.13 [19.15.15.13 NMAC] and 4.12.A(2) [19.15.4.12.A(2) NMAC].

It is our understanding that you are seeking this location to avoid interference with existing surface installations

It is also understood that notice of this application to offsetting operators or owners is unnecessary due to common ownership.
