Re: Application of Yates Petroleum Corporation for administrative approval of a 279.46 acre non-standard gas spacing unit for its Coogan "AUN" State Well No. 1 located 660 feet from the North line and 1850 feet from the East line of partial Section 32, Township 20 ½ South, Range 22 East, NMPM, Eddy County, New Mexico.

Dear Mr. Fesmire:

Yates Petroleum Corporation, pursuant to the provisions of Division Rule 104 D (2) (b) and (c) adopted on January 18, 1996, hereby seeks administrative approval of a 279.46 acre non-standard gas spacing and proration unit for the Coogan "AUN" State Well No. 1 to be comprised of all of partial Section 32, Township 20 ½ South, Range 22 East, N.M.P.M., Eddy County, New Mexico.

Yates proposes to drill this well to test the Morrow, Atoka, Strawn, Cisco and Wolfcamp formations. These formations are developed on 320-acre spacing pursuant to the general rules of the Division.

This non-standard gas spacing and proration unit is necessary because of a variation in the legal subdivision of the United States Public Land Surveys. This unit is comprised of contiguous lots which lie wholly within a single governmental section and are joined by a common side. Attached is a plat which shows the subject spacing unit and all adjoining spacing units or leases. Also attached is a list of all parties affected by this application.

Since this non-standard spacing and proration unit comprises all of partial Section 32, there are no owners in the mineral estate who are excluded from this non-standard unit. On or before the date on which this application was filed with the Division, a copy of this application with all attachments thereto was mailed to all offset operators or mineral interest owners by Certified Mail – Return Receipt Requested. Each of these parties was advised that if they have an objection to the proposed non-standard spacing or proration


