
Describe Cause of Problem and Remedial Action Taken.*

Steel flow line developed a leak releasing crude oil and produced water, new connection and line were installed to alleviate the problem.

Describe Area Affected and Cleanup Action Taken.*

Release affected approximately 5' of the berm and an area outside of the berm flowing NW of the location. The outside area affected is 50' N of the berm, along a line 110' W, then follow a line 60' S, then a line 75' SE back to the berm at a point approximately 5 feet from the NW corner of the berm. The affected berm is to be excavated and removed, along with the area off of location to be excavated and back dragged. Vertical and horizontal delineation samples will be taken and analysis ran for TPH & BTEX (chlorides for documentation). If initial analytical results for TPH & BTEX are under RRAL's (site ranking is 0) a Final Report, C-141 will be submitted to the OCD requesting closure. If the analytical results are above the RRAL a work plan will be submitted to the OCD. **Depth to Ground Water: >100' (approximately 150', Section 7, T22S-R31E, per Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: > 1000', SITE RANKING IS 0.**
