Mesaverde Formation

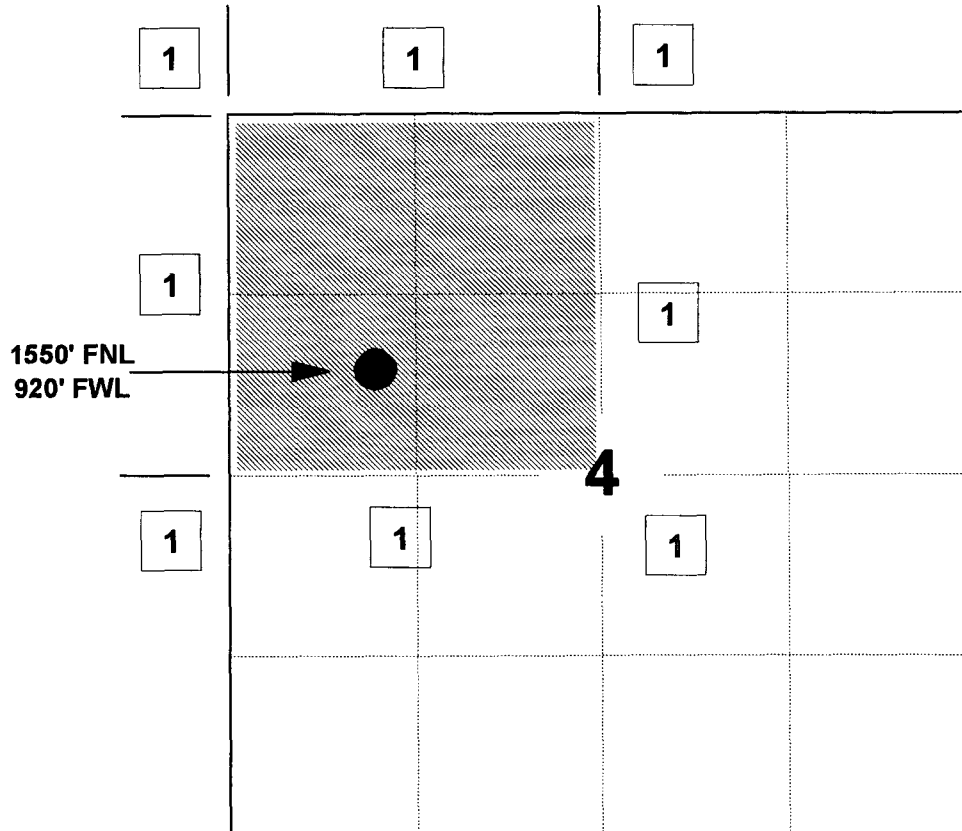
