1 inch roll line nipple on oil tank failed and cause the release of 25 bbls oil. Vacuum trucks were dispatched to remove standing fluid and any fluid in the tank to make necessary repairs.

Describe Area Affected and Cleanup Action Taken.*

The impacted area was 20' x 10' and contained within the bermed area. Concho will have the spill site sampled to delineate any possible contamination from the release and we will present a remediation work plan to the NMOCD for approval prior to any significant remediation work.
