

Found leak just east of West B. #40. at the tinorns on east side of road. Called Benco for to empty tinhorn & find leak. Found the 2 in fiberglass line in the south tinhorn had blowed into.. Had to leave lines 1 & 2 shutin due to leak on trunk line. Shut all laterals in on trunk line. Waiting on one call to clear for repairs.

Describe Area Affected and Cleanup Action Taken.* : Area covered was 33 feet long, 16 feet long. Covering the area of a previous leak, that is on agenda to be cleaned up.
