Describe Cause of Problem and Remedial Action Taken.*

While loading from the battery, a driver fell asleep causing an overflow from his truck, losing approximately 50 barrels of crude oil onto the facility pad. At 3:30 am the trucking company notified Murchison of the release and approximately 16 barrels were recovered, resulting in a net release of approximately 34 barrels.

Describe Area Affected and Cleanup Action Taken.*

The impacted material was immediately removed to a plastic liner placed on site and clean caliche was used to replace the pad material. The oily material was removed to a permitted disposal facility.
