Describe Cause of Problem and Remedial Action Taken.*



Electrical failure resulted in tank overflow. SWD well was worked over and evaluated. Due to the condition of the well and associated equipment, this well has been plugged and abandoned. All associated equipment has been removed from the location.

Describe Area Affected and Cleanup Action Taken.*

This location was sampled for analyses to delineate Total Petroleum Hydrocarbon (TPH) and Chloride (Cl) contamination levels. Caliche surfacing the well pad along with all contaminated soil exceeding the Recommended Remediation Action Levels (RRAL's) established by the OCD was excavated and removed from the location for disposal at Gandy Marley's Triassic Park Waste Disposal Facility (EPA I.D. No. NM0001002484). The excavated area was backfilled, covered and feathered to blend with the natural contour of the land with clean topsoil that was purchased from the land owner. The covered area was disked and seeded with BLM Warm Season Blend INV #53818 to match surrounding indigenous flora. Fertilizer and fresh water were applied to augment rapid site vegetation. Attached report documenting site closure actions was submitted to the OCD on 10/01/2014 and approved on 10/06/2014.
