

# REQUEST FOR ADMINISTRATIVE APPROVAL APACHE CORPORATION'S T REX STATE 1 30-015-41770 330' FNL & 2270' FEL SECTION 31, T. 17 S., R. 28 E., EDDY COUNTY, NM

I. This proposed oil well is on private surface and a State oil and gas lease in a smaller than standard section (below). The well is nonstandard (18' too far west) for the Artesia; Glorieta-Yeso Pool (96830) due to pipelines on the southeast (see EXHIBIT A). Apache requests a nonstandard location due to land uses. A standard location would force 1 buried pipeline and 3 surface pipelines to be moved. In addition, there are 2 existing oil wells (Empire; Yates – Seven Rivers), 4 other proposed Apache wells (all Artesia; Glorieta-Yeso), multiple roads, an overhead power line, and a guyed communications tower in the quarter-quarter.

A standard location must be  $\geq$ 330' from the boundary of the quarterquarter according to Order R-8539 et al. In this case, it is  $\approx$ 312' from the west side of unit letter B. (The north side of the NE4 of Section 31 is shorter than normal. Length of the north side of NE4 Section 31- is 2,581.92' instead of 2,640'.)



II. Form C-102 showing the well and 40-acre dedication is attached as Exhibit B. The well is 18' too far west.

III. Lease boundaries are shown on EXHIBIT C. The well encroaches to the west, northwest, and north. Artesia; Glorieta-Yeso (O) {96830} dedications exist in unit letters A, B, and H of Section 31. Red Lake; Glorieta-Yeso, Northeast {96836} dedications existing unit letters N, O, and P of Section 30 and unit letter G of Section 31. There are no Glorieta or Yeso dedications in unit letters C and F of Section 31. See Exhibit D for Glorieta-Yeso unit operators. This information is current and correct.

IV. Archaeology is not an issue.

V. Surface issues (3 surface pipelines and 1 buried pipeline) and the need to prevent waste and recover additional reserves drive the need for this nonstandard location.

VI. Apache does not believe directional drilling to a standard location is cost effective for this well.

VII. 


