David,

There was a greater loss than Devon thought. They did not know that the firewall was breached until I did my inspection and discovered the breach. Of course the bottom of the firewall is rotted out in many places, so it should have been a given. What was in the firewall was recovered. None of the fluid that was breached was recovered. There is a trail from the facility firewall to the area noted on the map that I did not notice as being an area of impact. This area will also need to be excavated. There was also a breach to the firewall on the southwest north of the entrance leading to the large mesquite that will also need to be excavated. After material is excavated, bottom samples will need to be taken for closure. 2' was 8080 ppm and 3' was 416 ppm. We need to make sure that at 2'11", for example, is not high. These can be field titrations. This area is in a low spot / pooling area where water collects. Any chlorides left behind will resurface rather quickly. Keep me in the loop. Thanks.
