It looks like we will only have to remove approximately 6" of material in the pasture to the south of the facility (SP-1 & SP-2). The area where the equipment is will be a little deeper (SP-3 & SP4). We hit refusal at 6' in the area of SP-2, so we may have to further delineate. The area of SP-4 looks to clean up around 4' below surface, and we hit refusal at 6' in this area as well.
