Yates Petroleum Corporation has begun work on our Tenneco "ADP" State Com Well No. 1, located in Sec. 2, Township 11S, Range 34E, Lea County, New Mexico (Administrative Order SWD-939).

We have deepened the well as outlined in our permit application but have not encountered the permeable interval we expected. We would like to drill the well deeper. We estimate a total depth of 13,500' will be sufficient. Current TD is 13280'.


Can this request be handled administratively or will it require re-submission of the C-108? We are anxious to get this well in service as we have several projects awaiting the well's completion

The proposed well the Tenneco ADP State Com No. 1 located 330' FSL & 990' FEL, Unit A, Section 2, Township 11 South, Range 34 East of Lea County, New Mexico, will be used for saltwater disposal. Disposal waters from the Devonian, Mississippian, Morrow, Atoka and Penn Sands will be injected into the Devonian Dolomite at a depth of 13133'-13500' with a maximum pressure of 2500 psi and a maximum rate of 10,000 BWPD.
