



BP America Production Company respectfully requests an administrative approval for a non-standard well location for the Case A 4M to be drilled at a location of 2580' FNL and 2105' FEL of Section 18, T31N-R11W.

The NSL is necessitated by topographical conditions with steep terrain - and would insure the conservation of surface and subsurface resources in the area. The location was staked non-standard for the Dakota & Mesaverde formations in order to best fit the existing terrain and maintain footage away from rough topography and a drainage arroyo to the North/East of the site. This location will avoid any adverse impact.

To aid in your review attached is a C-102 and a 9 Section well Location plat, indicating the proposed well location and the existing Dakota & Mesaverde wells in the area. Also attached is a topographical map.


