Dear Mr. Stogner:

Burlington Resources proposes to drill the above referenced well location as a commingled well in the Mesaverde and Dakota formations and is applying for administrative approval of an unorthodox gas well location for the Basin Dakota formation. The Mesaverde formation falls within a standard location.

The subject well was staked 1700 feet FSL and 2215 feet FEL due to steep cliffs and rugged terrain within the legal spacing window for the Dakota formation, as shown on the attached Aerial Photography map. This location also lies outside of the Participating Area. Because we could not stake this well any further south or east due to steep terrain, Burlington Resources desires to use existing roadway for a portion of wellpad to avoid further surface damage to this area, as shown on attached Cut & Fill Diagram.






