Proposed Testing Procedure and Schedule

All of the wells will be equipped with an allocation meter to measure each individual well being any gas is commingled at the compressor. Fuel usage for the compressor will be purchased from Williams Field Services line and metered prior to utilization as shown on the site diagram.
