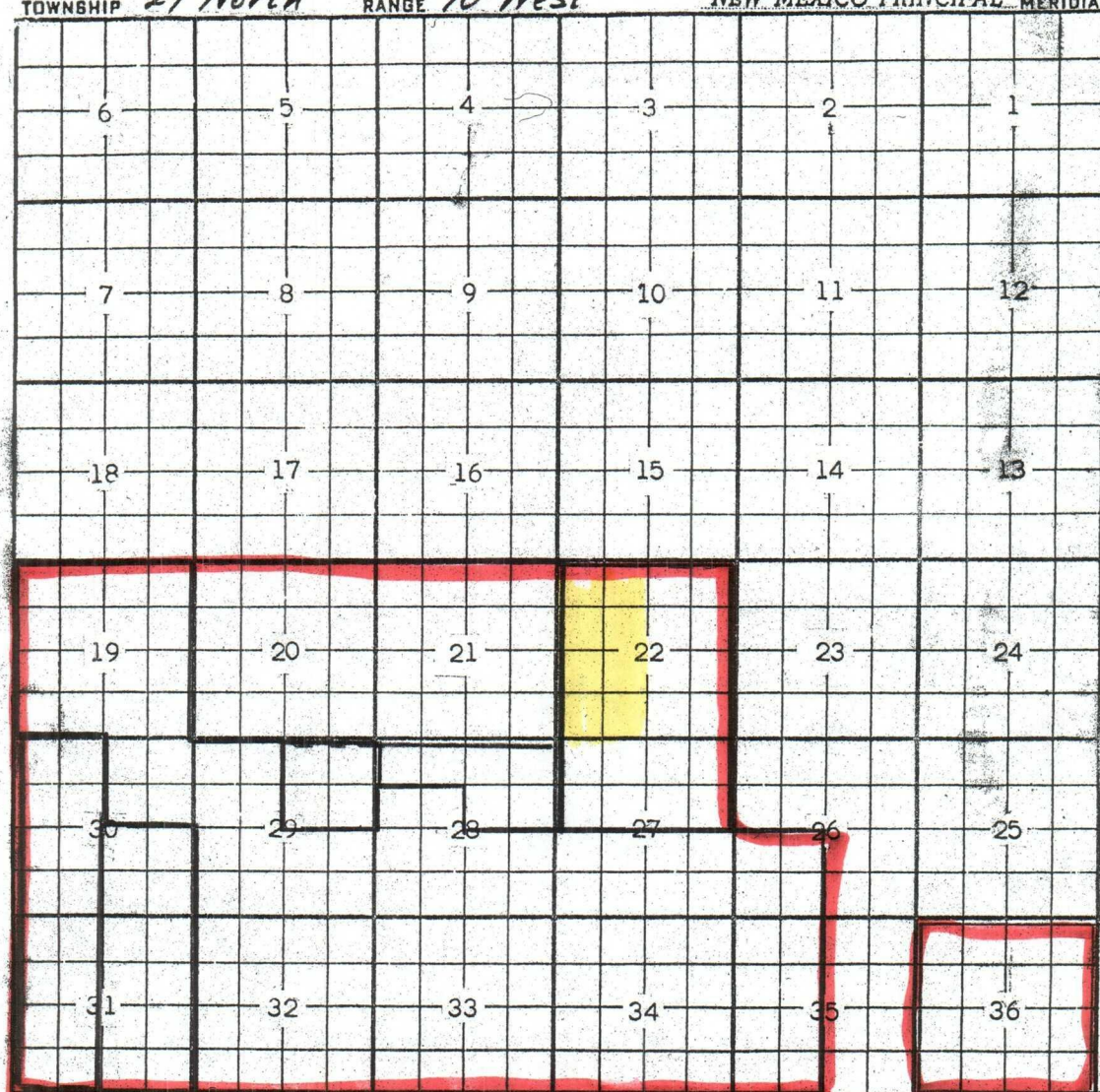


County San Juan Pool Angels Peak - Gallup Associated

I got a call from XTO about this well. It lies within the pool boundaries of the Angel's Peak Gallup and I held the C-104 for a NSL for the Gllp. They said they got a letter back stating that it should be in the Basin Mancos so that it would not need an order. The Basin Mancos was supposed to take up the spaces between the old Gallup pools where there is no real Gallup Formation and to provide uniformity of spacing with the other gas pools. We can't stick wells within the old pool boundaries in it without going to hearing, can we?
