This well flared intermittently: Nov 2015 11 days for ttl of 4,425 mcf; Dec 2015 6 days for ttl of 1,253 mcf; Jan 2016 3 days for ttl of 525 mcf. Total flared for C-129 11/01/15 - 01/31/16 is 6,203 mcf.
