



Enclosed is the supplemental page to EPNG's annual report to include one additional project where hydrostatic testing occurred under our Annual Temporary Discharge Permit, between June 10, 2015 and June 26, 2016.

Washington Ranch Storage Project, Located in Eddy County, New Mexico. EPNG drilled WI Federal #25 and installed 1,000 feet of new 6 inch diameter pipe, connecting it to an existing 10 inch line, known as WR-1001. EPNG also drilled WI Federal #26 and installed 1,400 feet of new 6 inch diameter pipe, connecting it to the existing 16 inch line, known as WR-1601. The water was recaptured from the first test (1,000 foot segment) and used to test the 1,400 foot segment.

- 1) Location: Sections 33 and 34, Township 25 South, Range 24 East, in Eddy County, New Mexico.
 - a. Well #25 = Latitude 32.08898; Longitude -104.49676
 - b. Well #26 = Latitude 32.07999; Longitude -104.48489
- 2) The date of the test was September 28, 2015.
- 3) The volume of water discharged was approximately 4,000 gallons.
- 4) The source of the test water was from a municipal supply from the City of Carlsbad.

The report summarizes each test of new pipe, with less than 25,000 gallons per hydrostatic test event that occurred between June 10, 2015 and June 26, 2016.

1. Line No. 1100 – Repair or Replace a Segment of Pipe (Immediate Remediation Project), Located in Lea County, New Mexico: Crews replaced approximately 80 feet on EPNG's 26" O.D. California Mainline (No. 1100) at Milepost 12+0860.

- 1) Location: Section 10, Township 22 South, Range 34 East in Lea County, New Mexico.
 - a) Latitude 32.4088817; Longitude -103.4573577
- 2) The date of the test was Monday March 28, 2016.
- 3) The volume of water discharged was approximately 2,200 gallons.
- 4) The source of the test water was a municipal supply from the City of Carlsbad

2. Construct the Ramsey North Receipt Meter Station, Located in Eddy County, New Mexico. EPNG installed the new meter station on Line Nos. 1100 and 1103 at Milepost 57+0000. The Project involved one hot tap, two ultrasonic meters, flow control valves and related appurtenances.

- 1) Location: Section 15, Township 26 South, Range 28 East in Eddy County, New Mexico.
 - a. Latitude 32.0405; Longitude -104.0773
- 2) The date of the test was Friday April 15, 2016.
- 3) The volume of water discharged was approximately 12,500 gallons.
- 4) The source of the test water was from a municipal supply in Carlsbad, New Mexico

3. Construct the Bounds Receipt Meter Station, Located in Eddy County, New Mexico. EPNG installed the new meter station on Line No. 3191 at Milepost 3+4242. The Project involved one hot tap, two ultrasonic meters, a flow control valve and related appurtenances.



4. Construct the Rock Dove Meter Station, Located in Eddy County, New Mexico. EPNG installed the new meter station on Line No. 1100 at Milepost 39+3600 located in Section 36, Township 24 South, Range 30 East of Eddy County, New Mexico. The Project involved one hot tap, valve assembly, two ultrasonic meters, a rotary meter and related appurtenances. In addition, the crews needed to install approximately 60 feet of new 24" O.D. pipe on Line 1100.

This project had no discharge on site. The test water was hauled to an approved disposal facility because the source water was not from a municipal water supply.

El Paso Natural Gas Company (EPNG) is submitting the following request for an Annual Temporary Permit to discharge waters from hydrostatic tests from new pipe. This application was completed using the OCD's Guidelines for Hydrostatic Test Dewatering, revised January 11, 2007. The current permit expires on June 26, 2016. A check for \$250.00, that covers the filing and permission fees, is enclosed within this submittal application.

In order to maintain coverage under the Annual Temporary Permit, EPNG will comply with the following conditions:

- 1) The volume will not exceed 25,000 gallons per hydrostatic test;
- 2) Water from a public/municipal water supply or other OCD-approved sources will be used for each test;
- 3) Written notification shall be provided to the OCD 72-hours prior to each hydrostatic discharge event;
- 4) The discharge will not enter any lake, perennial stream, river or their respective tributaries that may be seasonal;
- 5) No discharge shall occur to a surface water body without obtaining a National Pollution Discharge Elimination Systems (NPDES) permit from the US EPA, NMED and OCD prior to discharge;
- 6) Best management practices shall be implemented to contain the discharge onsite, prevent impact to adjacent properties, and to control erosion;
- 7) The discharge will not cause any fresh water supplies to be degraded or to exceed standards as set forth in Subsections A, B and C of the 20.6.2.3103 NMAC (the New Mexico Water Quality Control Commission Regulations)
- 8) The landowner(s) of each proposed discharge and/or collection/retention or alternative discharge location shall be properly notified of the activities prior to each proposed hydrostatic event; and
- 9) An annual report, summarizing all tests of new pipe with less than 25,000 gallons per hydrostatic test event, will be submitted to the OCD within 45 days after the temporary permission expiration date and shall contain the following information:
 - (a) The location of hydrostatic test (Section/Township/Range or GPS coordinates)
 - (b) The date of each test;
 - (c) The volume of each discharge; and
 - (d) The source and quality of test water (laboratory analysis, if necessary).
