
Re: Application of EOG Resources, Inc. for administrative approval of an unorthodox well location for its Hawk 26 Fed No. 710H Well in the E/2 E/2 of Section 35, Township 24 South, Range 33 East, N.M.P.M., Lea County, New Mexico.

Dear Mr. Catanach:

EOG Resources, Inc. (OGRID No. 7377) seeks administrative approval of an unorthodox well location for its **Hawk 26 Fed No. 710H Well** which is located within the Upper Wolfcamp Pool WC-025-G09-S243336I (Pool Code 98092) underlying Section 35, Township 24 South, Range 33 East, N.M.P.M., Lea County, New Mexico. This well will be drilled from a surface location 500 feet from the South line and 685 feet from the East line (Unit P) of Section 26. The upper most perforation will be located 10 feet from North line and 380 feet from the East line (Unit A) and the lower most perforation will be 330 feet from the South line and 380 feet from the East line of Section 35 (Unit P). Since this acreage is governed by the Division's statewide rules which provides for wells to be located no closer than 330 feet to the outer boundary of the spacing unit, the completed interval for this well will be unorthodox because it is closer than 330 feet to the northern and northeastern boundaries of the project area. Approval of the unorthodox completed interval will allow for efficient spacing of horizontal wells and thereby prevent waste.

Exhibit A is a draft Well Location and Acreage Dedication Plat (Form C-102), which shows that the completed interval of the proposed **Hawk 26 Fed No. 710H Well** encroaches on the spacing and proration units to the North and Northeast.

Exhibit B is a land plat for Section 35 and the surrounding sections that shows the proposed **Hawk 26 Fed No. 710H Well** in relation to adjoining units and existing wells.



EOG is the sole operator and mineral lessee of the federal lease covering the S/2 SE/4 of Section 26 and the SW/4 of Section 25. Accordingly, there are no parties affected by the encroachment to the North or Northeast. Nonetheless, a copy of this application has been provided to the Bureau of Land Management-Carlsbad Field Office.

Your attention to this matter is appreciated.


