Dear Mr. Leking,

On behalf of Siana Operating, LLC, this Well Pad Vertical Delineation Sampling Plan is to describe the work that includes the actions to be taken to complete delineation of chloride contaminated soil located at the aforementioned site on the well pad only per NM Oil Conservation Division (NMOCD) requirements.

Sampling Procedure

Three (3) soil borings will be drilled to approximately fifteen (15) feet utilizing air rotary drilling techniques. (See attached Final Sample Plan map denoting sample locations.) The depth of sampling may vary based on field sample results. Soil samples will be collected on the surface and every five feet below ground surface (BGS) utilizing conventional sampling techniques. All samples will be titrated to <250 mg/kg chloride concentration at the site and will then be delivered to a NELAP certified laboratory for confirmation analysis. The drilling unit will be decontaminated and all cuttings will be placed on a 40 mil liner for removal from the location to Sundance Services Inc. during the site cleanup and remediation.

The New Mexico Office of the State Engineer requires drilling permits for all boring installations. Permits must be obtained by Straub Corporation prior to the commencement of drilling activities.
