**Comments:**

Kodiak has been in business since 12-05. They don't have a C-133.

A DPS investigation in 12-08 indicated Kodiak was hauling produced water. Kodiak got in trouble with DPS for not having insurance/training/maintenance, etc. October 2009, ED and DOT investigated possible dumping on Kodiak site in open unpermitted pit after neighbor complained.

April 6, 2010 Randy went to Kodiak and explained need for C-133. Told them not to haul until they got one.

April 7, 2010 Kodiak signed C-133 application (which was not approved).

April 24, 2010 had rollover accident. Took truck back to lot and dumped contents.

May 19, 2010, we issued a formal denial of the C-133 application. We also called Kodiak in for a compliance conference. Told them we would not grant C-133 until site was cleaned up, and that they are not to transport oil field waste without C-133. They agreed to clean up site and stop transporting. Blamed former spouse.

Kodiak is working with Mike Bratcher on cleanup.

Once the cleanup is completed, Brad Jones wants a new C-133 application, because their other application is so old.

NB- we notified AG's office that this was a potential criminal case. However, when Kodiak took action to clean up site and stopped illegal transport, we backed off.

Mark Coffman of ED's hazardous waste bureau has been involved in the case, and we have tried to keep him informed. 505 222 9569.

At one point, it appeared that Mike was satisfied that he had gotten as much cleanup from Kodiak as he would ever get, and I thought we were going to close the file. Jim G talked to Mike, and on 1-12-11 Mike sent the operator a detailed list of what he would need in order to do a final inspection. We haven't heard anything since then. We aren't sure if they have disappeared, or are still hauling

Once Mike approves closure, we'll need to contact them and ask them for new C-133 application.

NB- the electronic file has a lot of documents that aren't in the hard file.

01/30/2012: Have reviewed file and have decided to close the file. If Artesia needs assistance in approving closure, file may be reopened. In regards to the C-133 application, Kodiak may choose to re-file but OCD will not be contacting them requesting they do so.



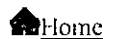
