EOG Resources, Inc. (OGRID No. 7377) seeks administrative approval of an unorthodox well location for its **Streetcar 15 Fed No. 602H Well** to be completed within the Draper Mill; Bone Spring Pool (Pool Code 96392) underlying Section 15, Township 25 South, Range 33 East, N.M.P.M., Lea County, New Mexico. The APD for this well has been submitted, but not yet approved by the BLM.

This well will be drilled from a surface location 250 feet from the South line and 643 feet from the East line (Unit P) of Section 15. The upper most perforation will be located 330 feet from South line and 1,375 feet from the East line (Unit O) and the lower most perforation will be 330 feet from the North line and 1,376 feet from the East line (Unit B) of Section 15. Since this acreage is governed by the Division's statewide rules which provide for wells to be located no closer than 330 feet to the outer boundary of the spacing unit, the completed interval for this well will be unorthodox because it is closer than 330 feet to the eastern, southeastern, and northeastern boundaries of the project area.

Ownership is identical in the E/2 of Section 15; ownership in the spacing unit towards which the proposed well is encroaching, the E/2 E/2, is common with the W/2 E/2. EOG has Bone Spring wells planned in the E/2 E/2 of Section 15. Approval of the unorthodox completed interval will allow EOG to use their preferred well spacing plan for horizontal wells in this area and thereby prevent waste.

Exhibit A is a draft Well Location and Acreage Dedication Plat (Form C-102), which shows that the completed interval of the proposed **Streetcar 15 Fed No. 602H Well** encroaches on the spacing and proration units to the East, Northeast, and Southeast.

As described above, EOG is the 100 percent interest owner in the spacing proration unit comprised of the E/2 E/2 of Section 15. Accordingly, there are no affected parties in the spacing units to the East of the proposed well. Each of the parties listed on Exhibit C have been provided notice of this application by certified mail. A copy of this application has been provided to the Bureau of Land Management-Carlsbad Office.




