Dear Mr. Catanach:

Chevron U.S.A. Inc. ("Chevron") (OGRID 4323) seeks administrative approval of an unorthodox well location for its **SD EA 29 Fed Com P8 No. 10H Well** (API No. 30-025-43269) to be completed within the Wolfcamp formation (WC-025-G09-S263327G; Upper Wolfcamp Pool (98097)) underlying the E/2 E/2 of Section 29 and the E/2 E/2 of Section 32.¹ This well will be drilled from a surface location 136 feet from the North line and 1657 feet from the East line (Unit B) of Section 29. The first perforation will be located 330 feet from the North line and 1170 feet from the East line (Unit A) of Section 29 and the final perforation will be located 330 feet from the South line and 1170 feet from the East line (Lot 1) of Section 32. Since this acreage is governed by the Division's statewide rules which provide for wells to be located no closer than 330 feet to the outer boundary of the spacing unit, the completed interval for this well will be unorthodox because it is closer than 330 feet to the eastern, southeastern, and northeastern boundaries of the project area.

Chevron is the 100% working interest owner in the E/2 of Sections 29 and 32. Ownership in the spacing and proration unit in the W/2 E/2 is of Section 29 and 32 is therefore common with the proposed spacing unit and therefore there are no affected parties in the spacing units to the East. The W/2 E/2 of Sections 29 and 32 will be developed by the **SD EA 29 Fed Com P8 No. 9H** (API No. 30-025-43268). Approval of the unorthodox completed interval will allow Chevron to develop these sections using their preferred well spacing plan for horizontal wells in this area, and thereby prevent waste of a productive reservoir.

Exhibit C is a list of the parties affected by the encroachment to the Northwest and Southwest. As described above, Chevron is the operator in the spacing unit it the W/2 E/2 of Sections 29 and 32 and ownership is identical with that of the subject spacing unit. For these reasons, there are no affected parties in the spacing unit to the West. Parties affected by the unorthodox location are located in the spacing units to the Northwest and Southwest. 
