

Re: Request for Extension of Administrative Order SWD-1585 pertaining to Probity SWD, LLC's Pardue 30 Com No.1 SWD ; API No.30-015-24144, located in Section 30, T23S-R28E, NMPM, Eddy County, New Mexico.

Dear Mr. Catanach,

Probity SWD, LLC has actively been working on the subject well in preparation for disposal operations. A recent workover has been performed and documented with a C-105 and sundry notices of all operations; the last being a successful MIT test. Operations included several cement squeezes, perforating and plug back to the permitted interval and depth. In final preparations, Probity SWD has designed a step-rate test to determine optimal rates and pressures. The service company performing the test has it scheduled for September 18th and the Artesia district office will be notified prior to allow OCD personnel to witness the test.

While the timing is close, the current expiration date is October 1, 2017. Probity SWD would like to extend the commencement date to provide for any contingencies that could arise during the final well and facility preparations

I have reviewed the subject Area of Review and determined that no significant changes have taken place. Leases and offset interested operators are the same; no new wells drilled. The SWD well has already been configured exactly as originally permitted. A wellbore diagram illustrating the current configuration is attached to this request.

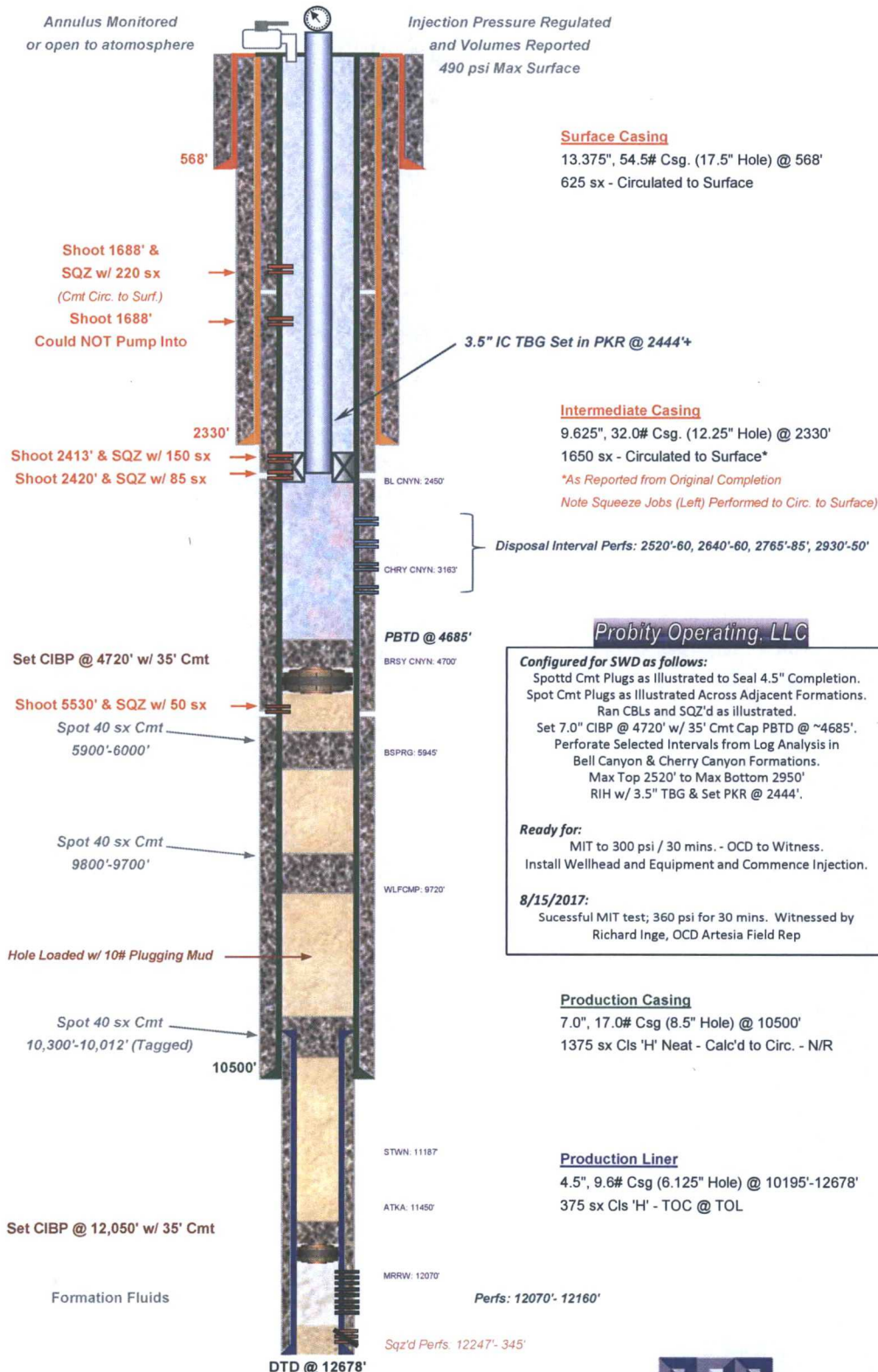
