Devon had the following release occur at 9:15 AM MST on 01/08/18. The incident is described below.

- 1. Parkway West SWD 1 (API #30-015-40835)
  - a. The SWD facility received a slug of oil from one of the batteries and over flowed the oil tank into the line SPCC containment ring. The lease operator opened the equalizer value to the tanks and equalized the fluid level and dispatched a vacuum truck to remove fluids from the lined containment. Approximately 39 bbls of oil was released and approximately 39 bbls oil was recovered.

A C-141 will be prepared and submitted with GPS coordinates of the areas affected.
