

Describe Cause of Problem and Remedial Action Taken.*

During water transfer job, operator did not hear radio command to close valve. This caused 40bbl of fluid to release into impervious lined containment. Valves were shut properly and vacuum truck dispatched.

Describe Area Affected and Cleanup Action Taken.*

The release affected the area within impervious lined containment. All fluids were recovered from the containment by vacuum truck. A SH&E Coordinator who is competent in the operation, maintenance, and inspection of all on-site equipment and facilities visually inspected the containment and verified there was no visual evidence of a liner breach.
