Fasken Oil and Ranch, Ltd. (OGRID No. 151416) seeks administrative approval pursuant to Division Rule 19.15.15.11.C NMAC to recomplete the above referenced vertical well in the Cemetery Wolfcamp Gas Pool in same quarter section as the Fasken State 32 Com No. 1 (API No. 30-015-21028) located in NW/4 NW/4 (Unit D) of Section 32, Township 20 South, Range 25 East, N.M.P.M., Eddy County, New Mexico. The Cemetery Wolfcamp Gas Pool is subject to the Division's statewide rules providing for 320-acre spacing and allowing no more than one well per quarter section. *See* NMAC 19.15.15.10.B. Fasken's proposed recompletion of the Fasken State 32 Com No. 3 (API No. 30-015-34535) in the Cemetery Wolfcamp Gas Pool will result in two vertical wells in the same quarter section, one in Unit D and one in Unit F of the NW/4 of Section 32.

The Fasken State 32 Com No. 3 was originally drilled and completed in the Cemetery (Morrow) Pool in 2006. This well was re-completed in the Seven Rivers Hills; Atoka, North Pool in 2010 and recently perforated in the Dagger Draw; Upper Penn, South (Assoc) Pool. This well is not economic. Fasken therefore seeks to recomplete this well uphole at a standard location in the Wolfcamp formation to salvage the wellbore.

Enclosed **Exhibit A** contains the Form C-102 for the existing Fasken State 32 Com No. 1 in the Cemetery Wolfcamp Gas Pool and the currently filed Form C-102 for the Fasken State 32 Com No. 3 well. **Exhibit B** is a plat identifying the location of the existing 320-acre spacing unit comprised of the N/2 of Section 32 dedicated to the Fasken State 32 Com No. 1, the location of the No. 3 well and the offsetting affected spacing units. **Exhibit C** lists the parties in the offsetting spacing units affected by the proposed addition of the Fasken State 32 Com No. 3 well

in the 320-acre spacing unit. 


