I. This shut-in well is on Navajo Tribal surface within the Navajo Indian Irrigation Project and on BLM oil and gas lease NMNM-7787. The well is nonstandard for the Basin Fruitland Coal Gas due to land use (proposed center pivot irrigation fields). A standard location must be at least 660' from the outer boundary of the 320 acre spacing unit. This well is staked 460' further north than is standard. (Closest standard location would be 660' FNL and 2180' FWL.) The APD cover sheet is attached as EXHIBIT A. (The former operator was Calpine. The former well name and number was Strider 25.)

II. A C-102 showing the well location and pro ration unit (N2 for the Basin Fruitland Coal Gas) is attached as EXHIBIT B. Relevant parts of the lease (960 acres) are shown as solid lines on the attached (EXHIBIT C) copy of the Moncisco Wash USGS topo map. The other Basin Fruitland Coal Gas well in the N2 Section 25 dedication is Pogo's Gallegos Federal 25 26 13 1 which is 2,400' away.

The well encroaches on the S2 Section 24. However, that is part of the same Pogo operated BLM lease. Basin Fruitland Coal Gas acreage dedications (half sections) are shown on Exhibit D.

The S2 Section 24 is dedicated to Pogo's two existing Basin Fruitland Coal Gas wells. Pogo's Gallegos Federal 26 13 24 #2 is 1,800' away at 1450' FSL & 2380' FEL Section 24. Pogo's Gallegos Federal 26 13 24 #2 is 1,844' away at 900' FSL & 700' FWL Section 24. Basin Fruitland Coal Gas wells (circled) within a mile radius are shown on EXHIBIT E.

III. According to NM Oil Conservation Division records reviewed on May 31, 2006; the closest existing or planned Basin Fruitland Coal Gas well is Pogo's producing Gallegos Federal 26 13 24 #2 which is 1,800' away at 1450' FSL & 2380' FEL Section 24.

Registered letters were sent on June 2, 2006 to all of the offset interest owners. Copies of the postal receipts and letters are attached.

IV. A copy of the USGS map is attached (EXHIBIT F) and the well site is marked. Pro ration unit (solid outline) for the Basin Fruitland Coal Gas is the 320.00 acre north half of Section 25, Township 26 North, Range 13 West, San Juan County, NM.

V. The nonstandard location is due to proposed land use (irrigated fields). The well was initially staked at 660' FNL & 660' FWL. This was rejected by the Navajo Agricultural Products Industry (NAPI) because it would have interfered with future irrigated fields (see Exhibit G). It was then moved to 200' FNL and 2180' FWL which met with NAPI's approval.

VI. No archaeology sites were found.

VII. See item V. above and attached map for a description of the surface conditions.

VIII. Directional drilling is not feasible because it is not cost effective.

IX.
