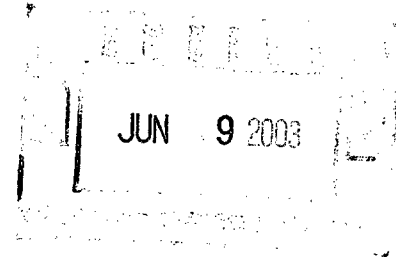

Gentlemen:

By copy of this letter, Doyle Hartman hereby makes application for the recompletion and simultaneously dedication of the marginal Stevens "B-35" No. 1 Langlie Mattix well (P-35-23S-36E), as the third Jalmat gas producer situated on the currently-existing 280-acre non-standard **communitized** Jalmat gas proration unit consisting of the SW/4, W/2SE/4, and SE/4SE/4 Section 35, T-23-S, R-36-E, Lea County, New Mexico (NMOCC Order No. R-3425, dated April 1, 1968). Upon approval of this application, the Stevens "B-35" No. 1 well will be renamed the Stevens "A-35" **Com** No. 4 well.

Application is also herein made for approval of the **existing** Stevens "B-35" No. 1 well location as an unorthodox Jalmat **gas** location consisting of 990' FSL and 660' FEL, Section 35, T-23-S, R-36-E, Lea County, New Mexico.

Recompletion of the Stevens "B-35" No. 1 well, at this time, will reduce the current high well operating cost, and allow for **continued** active well operations, by shutting off excessive Langlie Mattix water production. Also, and very importantly, it will facilitate the attempted recovery of otherwise unrecoverable Jalmat gas reserves, from tighter gas-productive strata (within the Jalmat

Pool interval), during the current period of economically favorable gas pricing, and corresponding period of **reduced** North American gas deliverability, and historically-low gas storage inventory levels.


