It is my understanding that this unit is to be simultaneously dedicated to the existing Wells "B-1" Well No. 4 (API No. **30-025-25532**), located at a standard gas well location 1980 feet from the South line and 660 feet from the East line (Unit I) of said Section 1 and to the newly drilled Wells "B-1" Well No. 7 (API No. **30-025-32756**), located at an unorthodox gas well location 1930 feet from the North line and 1780 feet from the East line (Unit G) of said Section 1.



Reference is made to your application dated February 5, 1996 to reduce the acreage of the existing 240-acre non-standard gas spacing and proration unit ("GPU") in the Jalmat Gas Pool comprising the S/2 NE/4 and SE/4 of Section 1, Township 25 South, Range 36 East, NMPM, Lea County, New Mexico, which was approved by Division Administrative Order NSP-1056-A(L)(SD), dated July 6, 1995, by omitting the 40 acres comprising the NE/4 SE/4 (Unit I) of said Section 1 from said GPU. Said Order NSP-1056-A(L)(SD) further authorized the simultaneous dedication of the 240-acre unit to the Well "B-1" Well No. 4 (API No. 30-025-25532), located at a standard gas well location 1980 feet from the South line and 660 feet from the East line (Unit I) of said Section 1 and the Well "B-1" Well No. 7 (API No. 30-025-32756), located at an unorthodox gas well location 1930 feet from the North line and 1780 feet from the East line (Unit G) of said Section 1.

It is our understanding that such reduction of acreage is necessary due to the re-classification of the Wells "B-1" Well No. 4 as a Jalmat oil completion.



Reference is made to your letter dated February 20, 1996, Prime Operating Company is hereby authorized to simultaneously dedicate Jalmat Gas Pool production to the previously approved non-standard 80-acre, more or less, gas spacing and proration unit ("GPU") comprising Lot 4 and the SW/4 NW/4 of Section 1, Township 25 South, Range 36 East, NMPM, Lea County, New Mexico (Division Administrative Order NSP-1257, dated July 17, 1981, from the following two existing wells:

- the Wells "A" Well No. 2 (API No. 30-025-09720) located at a standard gas well location 1980 feet from the North line and 660 feet from the West line (Unit E) of said Section 1; and,
