Marbob Energy Corporation respectfully requests administrative approval for an unorthodox location of the George Federal Com #2 as referenced above. Enclosed is a copy of the OCD Form C-102 showing the proposed well spacing unit. Behind that is a map showing the proposed well, the original well in the proration unit and the offset spacing units and the affected spacing unit. The well location is unorthodox to the North boundary by 90 feet. The affected proration unit is operated by Marbob Energy Corporation. The next map in the packet shows an ariel view of the proposed section. This section, particularly in the West half is comprised of shinnery oak, grass and sand dune habitat which is home to the sand dune lizard which is on the state threatened species list. The surface and minerals owned in this section are Federal and the BLM has asked that we minimize our impacts in this area because of species/habitat issues. As you can see our location is just north of an existing road. What is not apparent from the ariel picture is the fact that a high pressure gas line also is buried on the South side of the road. As such we moved as close to the pipeline as possible but that left us 90 feet unorthodox to a standard location. We explored the option of moving south of the pipeline to build our location but the habitat impacts were far greater at that alternative and the BLM wanted the location on the North side. This location would be orthodox for any shallow horizons including the Delaware and Bone Springs and would only be unorthodox as to the deep horizons. We have worked with our geologist and biologist and this appears to be the best compromise location that everyone has agreed to. The BLM has approved the Application to Drill subject your approval.


Also this location is in the potash area but it has received approval for drilling. The offset proration units are listed below with their operator:

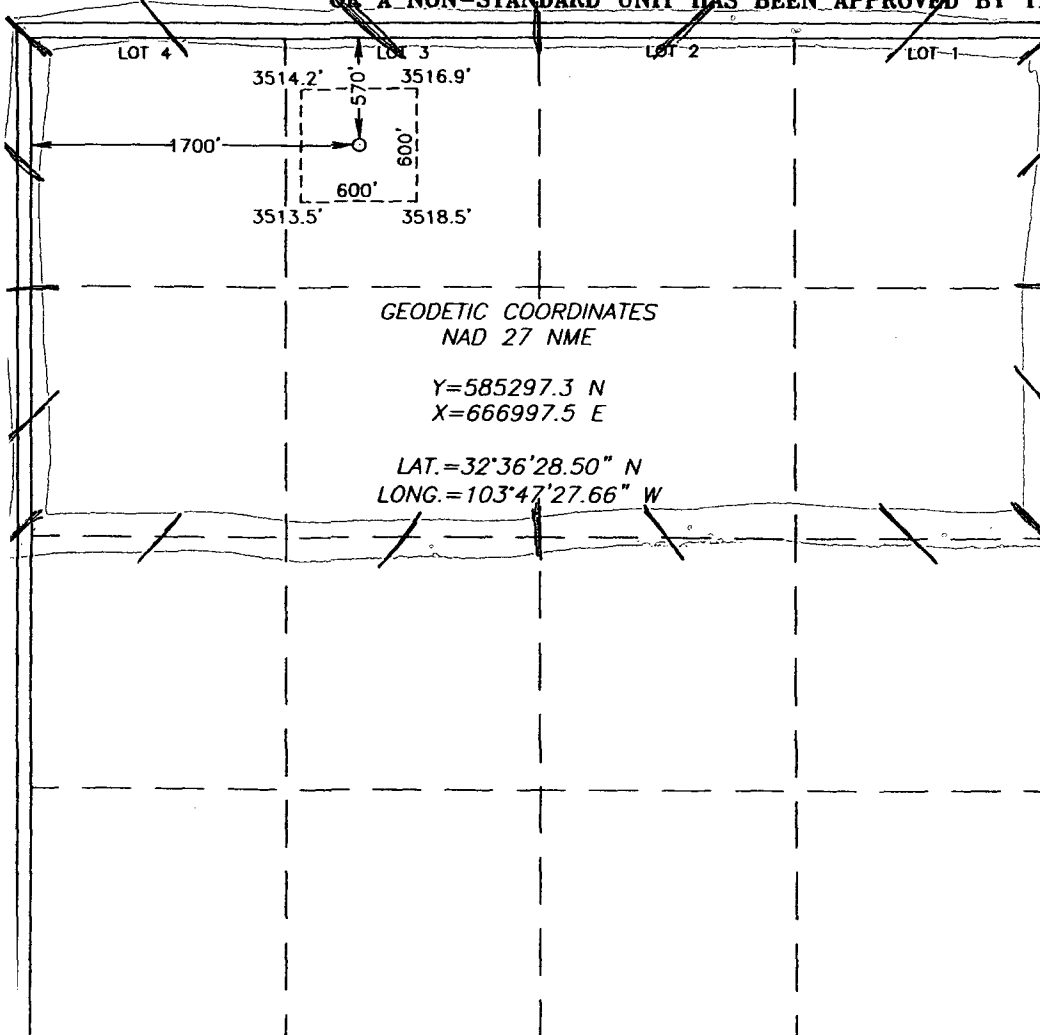

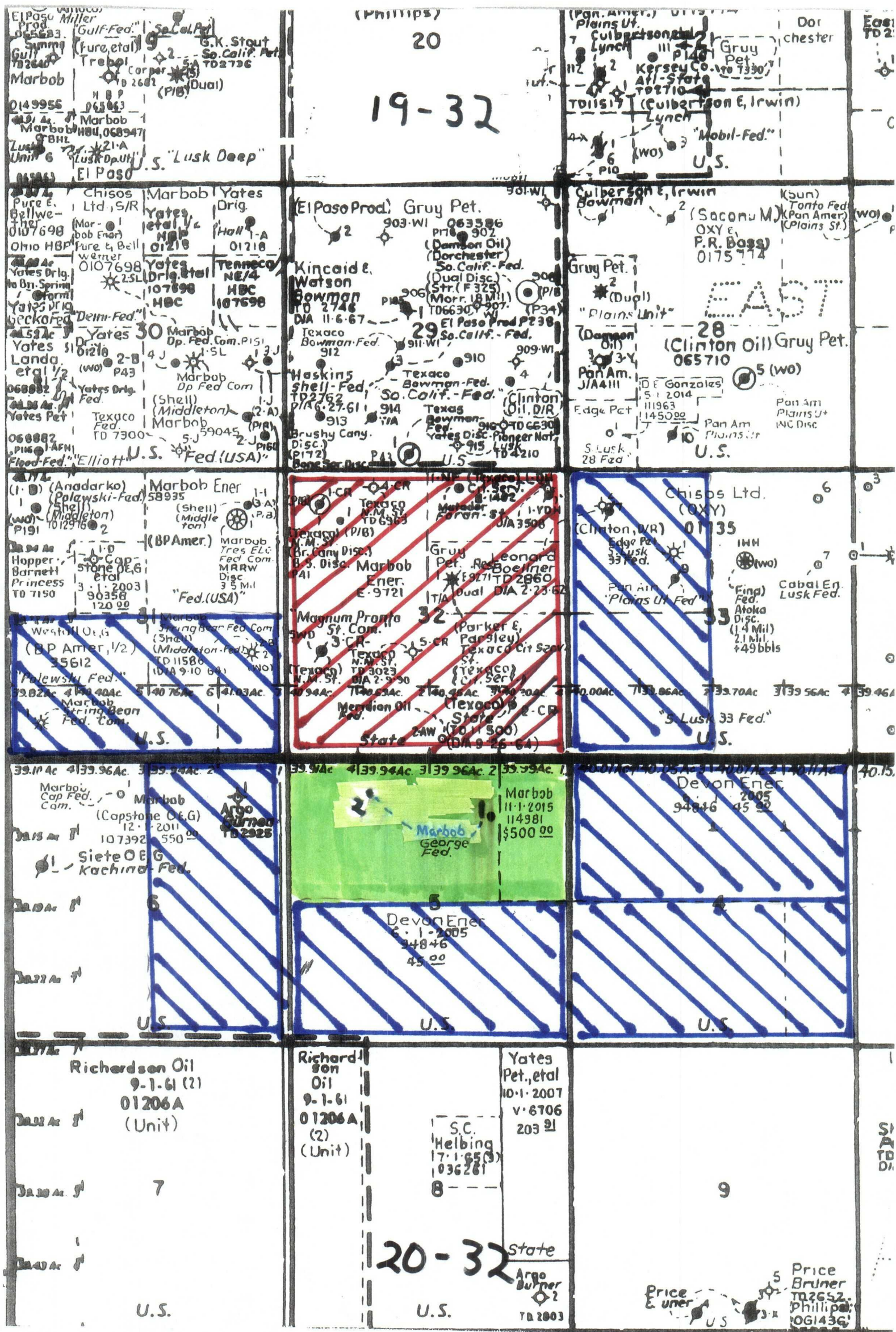

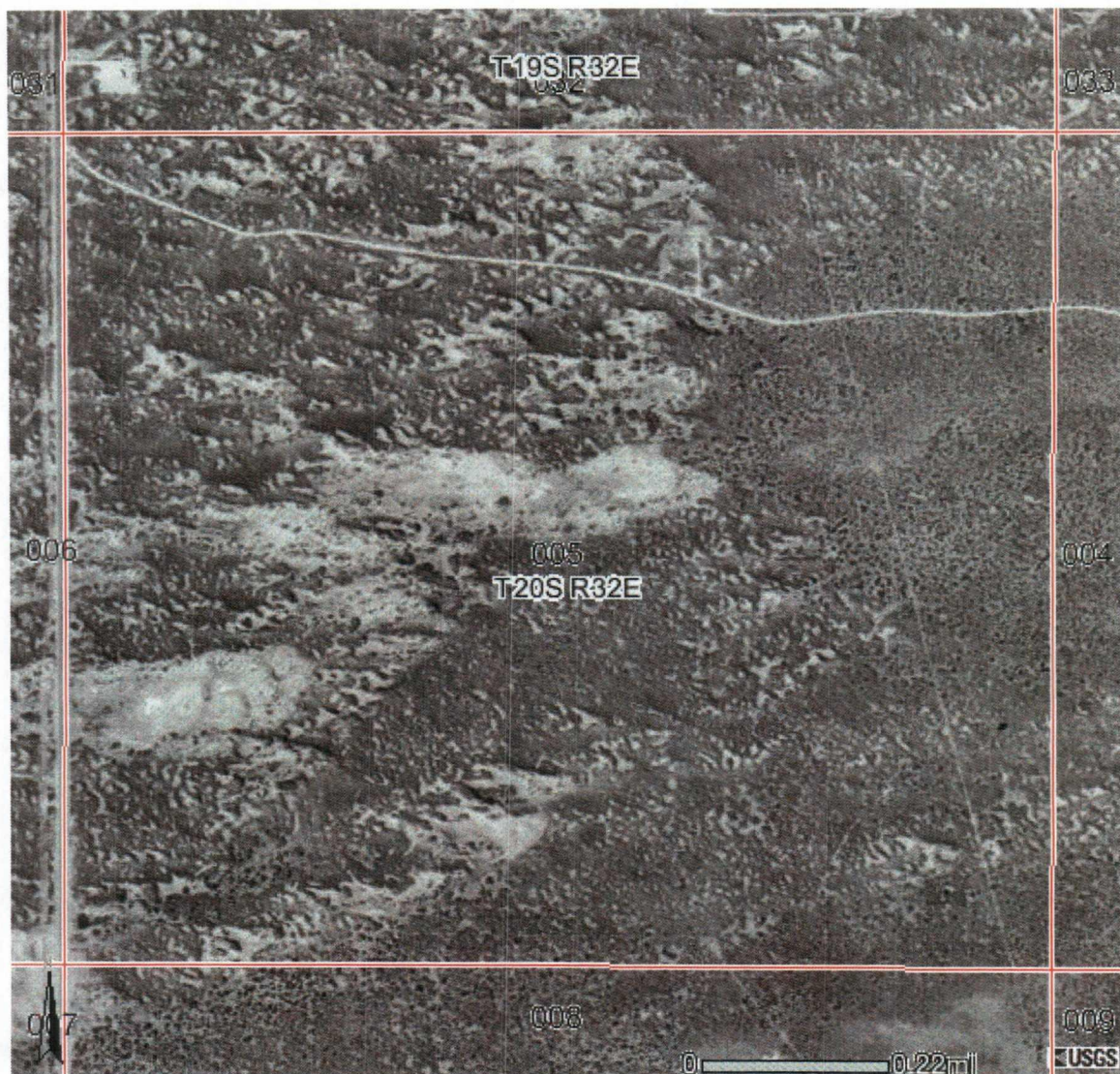
