Administrative Order NSP-1905

Dear Mr. Bruce:

Reference is made to the following:

- (a) your application (administrative application reference No. pTDS0630047652 for non-standard proration unit [NSP]) submitted to the New Mexico Oil Conservation Division (the Division) in Santa Fe, New Mexico on October 26, 2006, on behalf of Pogo Producing Company ("Pogo"); and
- (b) the Division's records pertinent to Pogo's request.

Pogo proposes to drill the above referenced well at the above referenced standard location within Section 21 and requests to produce Tansill-Yates-7Rvrs gas from the well within a proposed 160-acre, more or less, non-standard gas spacing unit within the Jalmat-Tansill Yates 7Rvrs Gas Pool consisting of the NE/4 of Section 21.

The Jalmat-Tansill Yates 7Rvrs Gas Pool (79240) is governed by "The Special Pool Rules for the Jalmat Gas Pool" issued in Order R-8170-P; which allow 640-acre gas well spacing units with up to one well per quarter section, such wells to be located at least 660 feet from the spacing unit boundary or quarter section boundaries.

Your application states that Division Administrative Order NSP-1895 established a non-standard spacing unit in the NW/4 of Section 21. In addition, the SW/4 and SE/4 are also being proposed as non-standard spacing units. It is our understanding that Pogo is the operator of all offsetting spacing units except for those in Sections 15 and 16. All operators or working interests have been notified in those two Sections.

Your application on behalf of Pogo has been duly filed under the provisions of Rule 4(C) of "The Special Pool Rules for the Jalmat Gas Pool" and of Division Rules 104.D(2) and 1210.A(3).

Pursuant to the authority granted under the provisions of Division Rule 104.D(2), the above-described non-standard Jalmat-Tansill Yates 7Rvrs Gas spacing unit is hereby approved.

Jurisdiction of this case is retained for the entry of such further orders as the Division may deem necessary.
