As Operator of the Northeast Blanco Unit, we request permission to drill an unorthodox well, to be located 1500' from the South line and 1800' from the East line of Section 19-30N-7W, Rio Arriba County, New Mexico.

NW/4 SE/4
The normal location for this well is situated in the NE/4 of Section 19. However, the Bureau of Reclamation has reserved the N/2 of Section 19 and the S/2 of Section 18, T 30 N, R 7 W for the Navajo Dam Project. It is, therefore, necessary that a location, within the SE/4 of Section 19, be selected. Because of the San Juan River Canyon, it is impossible to locate this well nearer the East-West half section line.

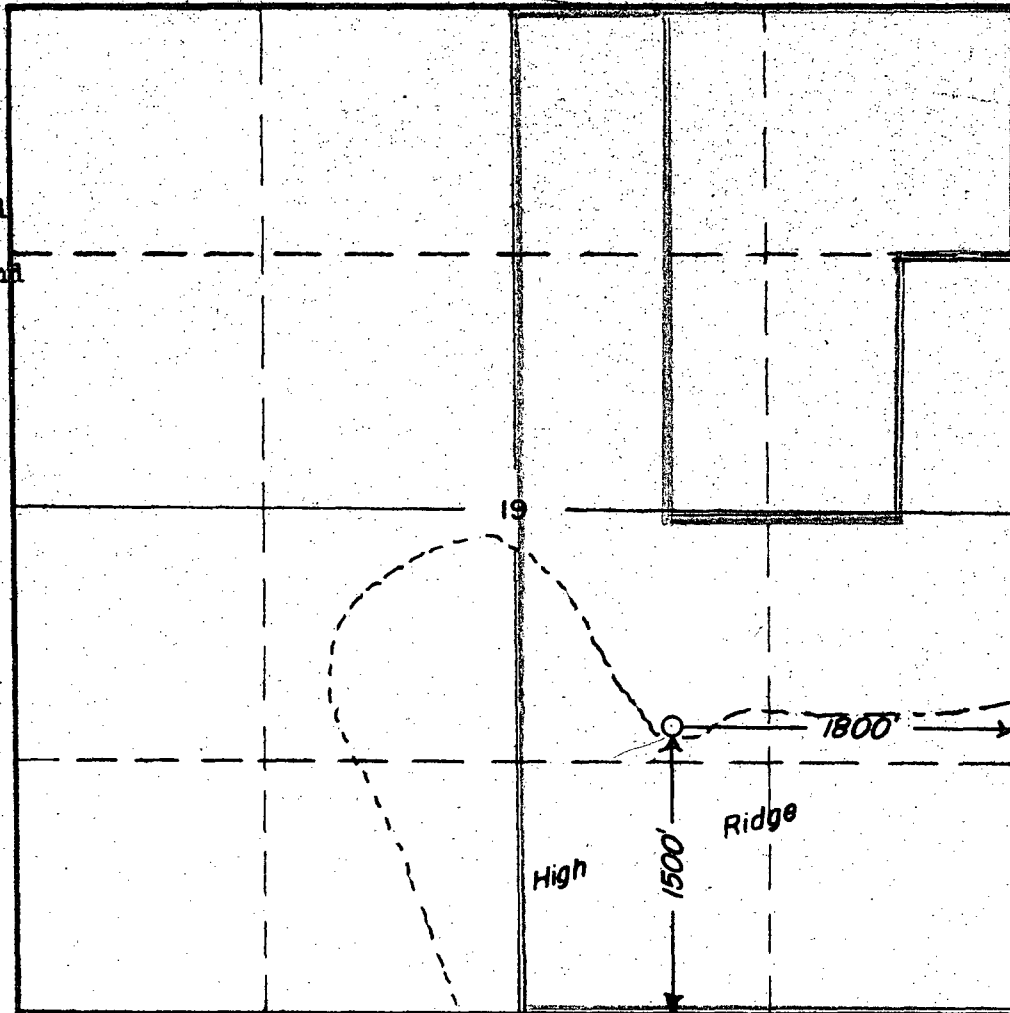
