Administrative Order NSL-131-A

Dear Mr. Cox:

Reference is made to the following: (i) your application (*administrative application reference No. pKRV0-310654857*) submitted to the New Mexico Oil Conservation Division ("Division") on April 14, 2003; and (ii) the Division's records in Santa Fe and Aztec, including the file on Division Administrative Order NSL-131: all concerning XTO Energy, Inc.'s request for an unorthodox gas well location in the Chacra formation for the existing Schwerdtfeger "A" LS" Well No. 15 (API No. 30-045-06403) located 865 feet from the North line and 2250 feet from the East line (Unit B) of Section 21, Township 27 North, Range 8 West, NMPM, San Juan County, New Mexico. The NE/4 of Section 21 is to be dedicated to this well in order to form a standard 160-acre gas spacing unit for the Otero-Chacra Pool (82329).

This application has been duly filed under the provisions of Division Rule 104.F, revised by Division Order No. R-11231, issued by the New Mexico Oil Conservation Commission in Case No. 12119 on August 12, 1999.

By Division Administrative Order NSL-131, dated February 5, 1958, El Paso Natural Gas Company of Farmington, New Mexico received authorization to drill to and complete the abovedescribed well in the Blanco-Mesaverde Pool at a location considered to be unorthodox at that time within a standard 320-acre lay-down gas spacing and proration unit comprising the N/2 of Section 21. According to Division records, Cross Timbers Operating Company, now XTO became the operator of this well on January 1, 1998.

It is our understanding that XTO now intends to recomplete this well up-hole to include the Chacra formation.

The location of this well within the Otero-Chacra Pool is considered to be unorthodox, pursuant to Division Rule 104.C (3),as revised.

By the authority granted me under the provisions of Division Rule 104.F (2), the abovedescribed unorthodox gas well location within the Otero-Chacra Pool is hereby approved.

Further all provisions of Division Order NSL-131 shall remain in full force and affect until further notice.

Dear Mr. Cox:

Reference is made to the following: (i) your application submitted to the New Mexico Oil Conservation Division ("Division") on October 22, 2003 (*administrative application reference No. pLR0-329549301*); (ii) your voice mail message concerning this application to Mr. Michael E. Stogner, Engineer/Hearing Officer in Santa Fe on Wednesday afternoon, November 19, 2003; and (iii) the Division's records in Santa Fe and Aztec, including the files on Division Administrative Orders NSL-131 and 131-A: all concerning XTO Energy, Inc.'s ("XTO") request for exceptions to the well location requirements provided within:

(a) the "Special Rules for the Blanco-Mesaverde Pool," as promulgated by Division Order No. R-10987-A, issued in Case No. 12069 and dated February 1, 1999, as amended by Division Order No. R-10987-A (1), dated December 2, 2002; and

(b) Division Rule 104.C (3), revised by Division Order No. R-11231, issued by the New Mexico Oil Conservation Commission in Case No. 12119 on August 12, 1999.

XTO proposes to drill its Schwerdtfeger "A" Well No. 25 at an unorthodox gas well location into both the Blanco-Mesaverde (72319) and Otero-Chacra (82329) Pools 2485 feet from the North line and 925 feet from the West line (Unit E) of Section 21, Township 27 North, Range 8 West, NMPM, San Juan County, New Mexico.

This application has been duly filed under the provisions of: (i) Division Rule 104.F, as revised; (ii) Division Rule 605; (iii) the special rules governing the Blanco-Mesaverde Pool.

Gas production from the Blanco-Mesaverde Pool is to be included within an existing standard 320-acre lay-down gas spacing and proration unit ("GPU") comprising the N/2 of Section 21, which is currently dedicated to XTO's: (i) Schwerdtfeger "A" LS Well No. 15 (API No. 30-045-06403), which is at a location now considered to be standard but unorthodox at the time it was drilled (spud-date, April 21, 1958) 865 feet from the North line and 2250 feet from the East line (Unit B) of Section 21(see Division Administrative Order NSL-131, dated February 5, 1958); and (ii) Schwerdtfeger "A" LS Well No. 15-A (API No. 30-045-29245), located at a standard infill gas well location 915 feet from the North line and 1770 feet from the West line (Unit C) of Section 21.

The NW/4 of Section 21 is to be dedicated to this well in order to form a standard 160-acre spacing unit for the Otero-Chacra Pool.

By the authority granted me under the provisions of Division Rule 104.F (2), as revised, and the applicable provisions governing the Blanco-Mesaverde Pool, the above-described unorthodox: (i) infill Blanco-Mesaverde gas well location; and (ii) Otero-Chacra gas well location, for XTO's proposed Schwerdtfeger "A" Well No. 25 is hereby approved.

Further, the three above-described Mesaverde gas wells (Schwerdtfeger "A" LS Wells No. 15, 15-A, and 25) and existing N/2 lay-down 320-acre GPU will be subject to all existing rules, regulations, policies, and procedures applicable to prorated gas pools in Northwest, New Mexico and to the Blanco-Mesaverde Pool.
