Dear Sir:

Application to drill the Kay Kimbell No. 2-35 Warren Federal proposed 7200' Dakota-Gallup dual location located 1015 feet from the south line and 1850 feet from the east line of Section 35, T. 25 N., R. 6 W., Rio Arriba County has been filed and approved by the U. S. Geological Survey at Farmington.

As this location is unorthodox for Otero Gallup oil (precipitous topography prevented an orthodox location), we respectfully request administrative approval for this unorthodox Gallup oil location.

As shown on the enclosed plat, offset operators (Skelly Oil Co. all of Section 2, 24N., 6W. to the south and unleased fee lands in N $\frac{1}{2}$ SW $\frac{1}{4}$ , SE $\frac{1}{4}$ NW $\frac{1}{4}$  of Section 35, 25N., 6W. to the northwest) are not affected by this location being unorthodox as we have moved farther inside our own lease.

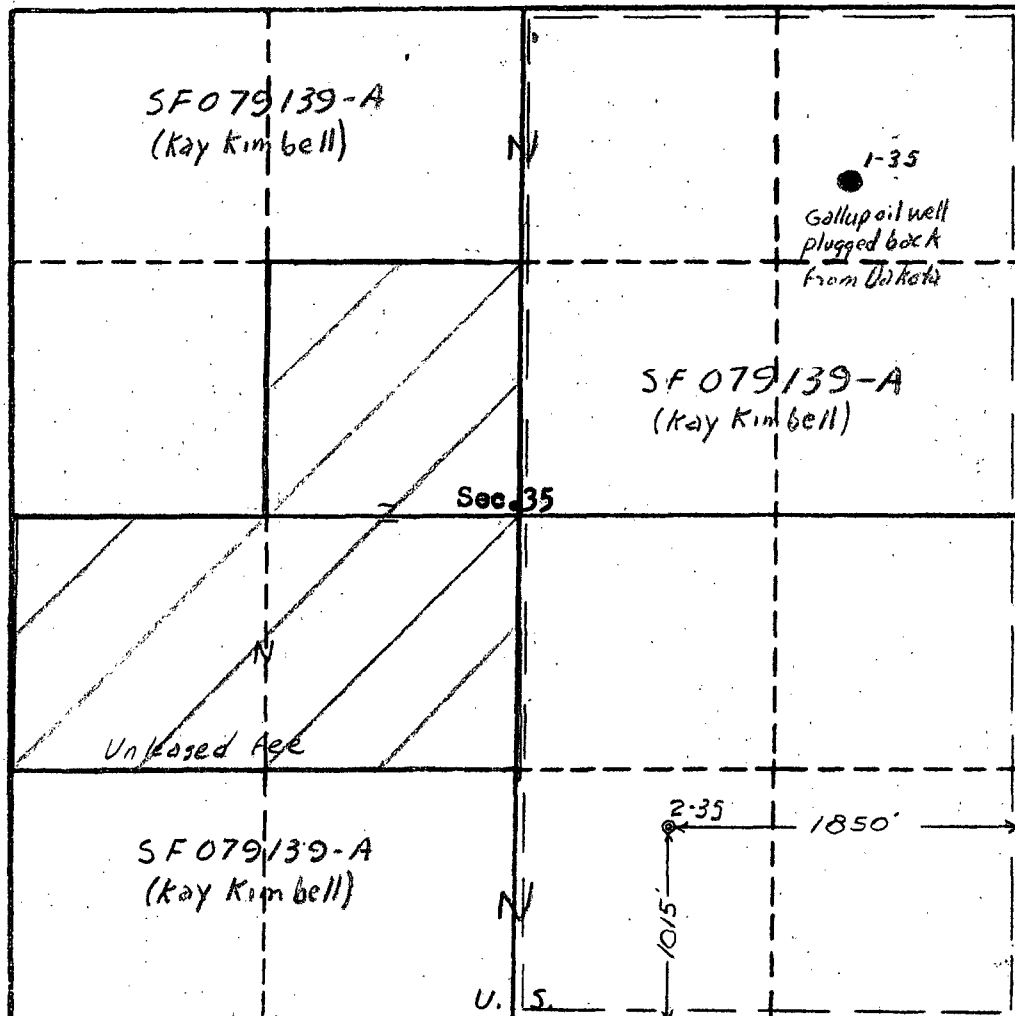
