This is a request for administrative approval for an unorthodox gas well location in the Blanco Mesa Verde Pool.

It is intended to locate the well, El Paso Natural Gas Co. San Juan 28-5 Unit No. 46, 1340 feet from the North line and 2349 feet from the East line of Section 25, Township 28 North, Range 5 West, N.M.P.M., Rio Arriba County, New Mexico. The N/2 of Section 25 is dedicated to the well.

As shown on the enclosed plat, the NE/4 consists of a rock ledge. only accessible land for a well in the NE/4 is that which makes the location unorthodox. It is, therefore planned to make the location unorthodox in order that the extremely high cost of constructing an orthodox location be avoided.
