Gentlemen:

Order No. R-1670-C states, "All wells drilled to or completed in the Basin-Dakota gas pool shall be located no nearer than 790' to the boundary line of the proration unit and shall be located no nearer than 130' to a governmental quarter-quarter section line or subdivision inner boundary line. In the event any such well is completed as an oil well at a location nearer than 330' to a governmental quarter-quarter section line, said well shall not be produced unless and until such time as the unorthodox oil well location has been approved by the Commission after notice and hearing."

✓ The British-American Oil Producing Company's Fullerton #8 was drilled at a location 1500' FNL and 1800' FEL. This location is proper for a Dakota gas pool. However, the Gallup Sand was found productive at this location and is consequently an unorthodox location for an oil well since it is located 180' from the nearest quarter-quarter section line. The well was initially staked 1850' FNL and 1980' FEL of Section 14 but was moved because of (inaccessible terrain.) The original location would have been off a fifty foot cliff running in a general east-west direction. Therefore, it was necessary to move the location north and east. Administrative approval is herein requested by your authority under Rule No. 3 of Order No. R-1670-C. A copy of our application has been sent to each offset operator and all operators within the section in which this well is located.

Fullerton #8 is within one mile of the forty acre Gallup oil preration unit dedicated to the British-American Fullerton #6 which is located 790' FWL and 1650' FNL Section 11-27N-11W.




