Re: Application for Approval of a Non-Standard Location for Stewart 29 Well No. 2, Section 29, T23S, R37E, Jalmat Gas Pool

Continental Oil Company requests an exception to Rule 2 of the General Rules and Regulations for Southeastern New Mexico contained in Order No. R-1670 for its Stewart 29 Well No. 2 at a location 2310 feet from the South line and 990 feet from the East line, Section 29, T23S, R37E, Lea County, New Mexico.

 Applicant is the owner of the Stewart 29 Lease consisting of S/2 SE/4 and NE/4 SE/4 Section 29, T23S, R37E, Lea County, New Mexico.

2. Applicant's Stewart 29 Well No. 2 was completed January 12, 1952, as a producer in the Langlie-Mattix Oil Pool at the location described above.

3. Said well has been recompleted as a Jalmat Gas Well and application for a non-standard gas proration unit consisting of the above described lease acreage has been submitted.

4. In accordance with the provisions of Rule 3, exception for the well's location is requested due to its having been recompleted after being drilled to another horizon


5. Copies of this application are being forwarded, this date, by Registered Mail to all operators within 1980 feet of the well.
