
Dear Mr. Morrow:

Pursuant to our telephone conversations on June 24 & 25, 1991, I am writing concerning Yates Petroleum Corporation's pending recompletion of the Johnston BE Federal #1 from the Boyd Morrow Gas Pool to the North Dagger Draw Uppper Pennsylvanian Pool, Eddy County, New Mexico. This well is located 330 FNL & 330 FEL of Section 8, Township 19 South, Range 25 East, N.M.P.M., Eddy County, New Mexico. The Johnston BE Federal #1 was originally drilled to 4075' in July, 1967 and subsequently was temporarily abandoned. Yates Petroleum Corporation re-entered this well in January 1972 under a permit to test the Cisco to a proposed depth of 7800'. Since this was an unorthodox location for the Cisco/Canyon formation Yates was granted an Administrative Order NSL-535 to deepen this well to the Cisco zone of the Pennsylvanian formation. A later modification of this order permitted a further deepening to the Morrow. This was an unorthodox location in the Morrow also. The well was deepened to 9222' and completed in the Boyd Morrow Gas Pool on April 28, 1972. This well has produced from Morrow from that date until the present. Our interpretation is that we can accomplish a recompletion into the Canyon formation because we find that:

- 1) The Canyon formation of the North Dagger Draw-Uppper Pennsylvanian Pool is the same as the subject Cisco formation of the original Administrative Order NSL-535.
- 2) The Administrative Order NSL-535 was only modified to include the Morrow formation and thereby is still in effect.
- 3) Said well also meets the criteria for an unorthodox location as provided for in Statewide Rule 104F(1).

Therefore, Yates Petroleum Corporation intends to proceed with this recompletion to the Canyon formation of the North Dagger Draw-Upper Pennsylvanian Pool.

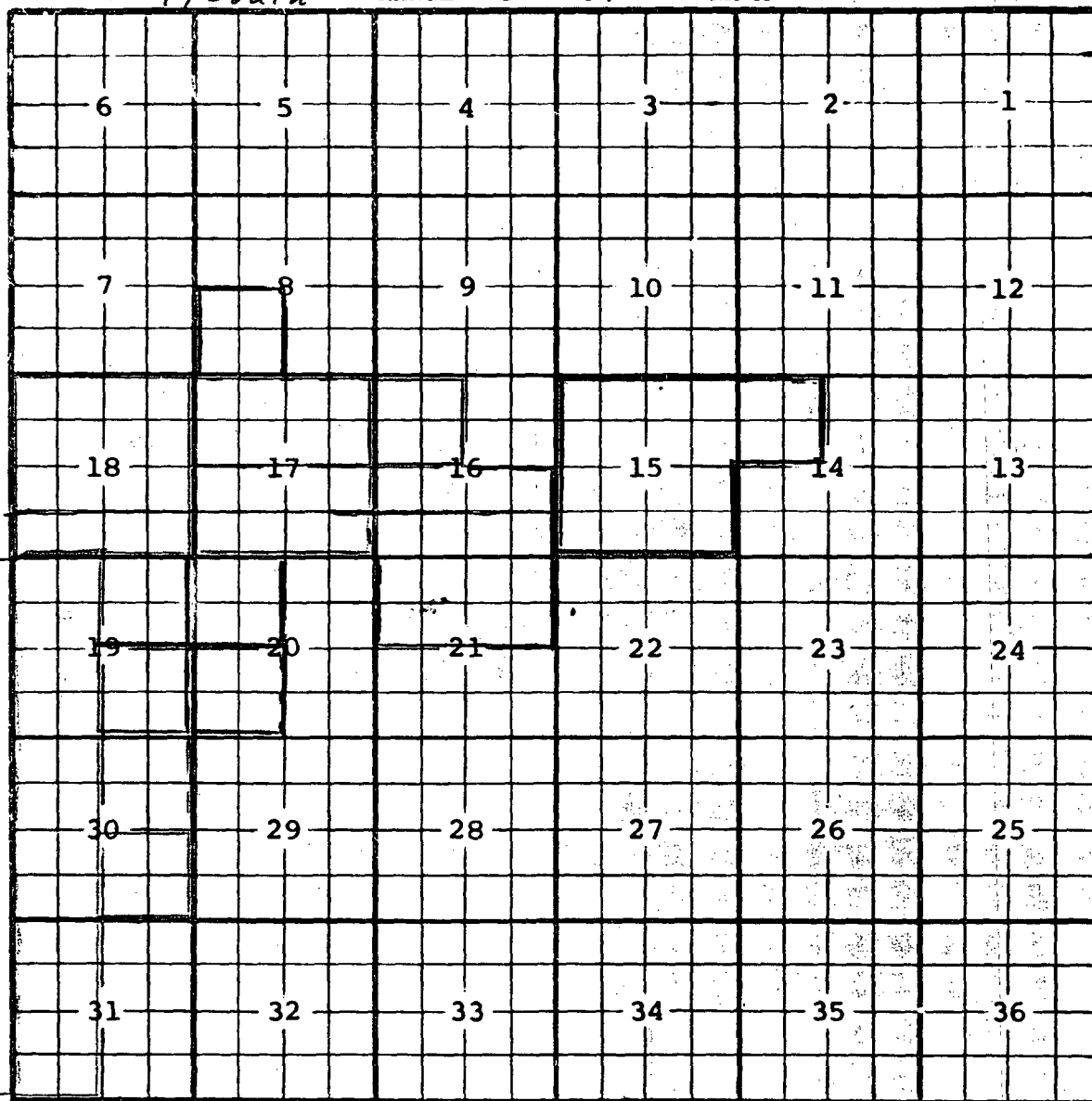
