Gentlemen:

Under the provisions of Rule 104 (F) Mobil 011 Corporation respectfully requests authority to drill the subject well at an unorthodox location. This well cannot be drilled at an orthodox location because of a lake on this particular part of the section. To minimize the risk of contaminating the lake in the event of heavy rains during drilling operations it is necessary to move the location 400 ft east of the center of the SE/SW 1/4 of the section. The location of this proposed well is 660' from the south line and 2380 ft from the west line of Sec. 7, T17S, R35E, Lea County, New Mexico.


