This letter acknowledges the receipt of your administrative application dated October 22, 2001 for the Jicarilla "20" Well No. 2 (API No. 30-039-05873) to be recompleted at an unorthodox gas well location in the South Blanco-Pictured Cliffs Pool (72439) 349 feet from the South line and 596 feet from the West line (Unit M) of Section 20, within a standard 160-acre gas spacing and proration unit comprising the SW/4 of Section 20.

The Division received this application on October 25, 2001, accepts it as an administrative application, and assigned it NMOCD application reference No. *pKRV0-130448636*. Please refer to this number in future correspondence with the Division.
