Dear Sir:

Shell Oil Company respectfully requests administrative approval for an unorthodox well location for Argo Well No. 12 in an undesignated pool, according to Rule 104 F. The well is located on Shell Argo Lease (160-acre tract), consisting of the SW/4 Section 15, T-21-S, R-37-E, Lea County, New Mexico.

The well was a Hare oil producer. The Hare was abandoned by setting a cast iron bridge plug above the Hare perfs and capping the bridge plug with cement. The well is to be recompleted in the San Andres with perforations at 3972', 3978' and 3985'. From log evaluations and production from Turner No. 16 (approximately one mile south of the subject well), which is presently in a testing status, it is believed that this is a gas pool.

Enclosed is a copy of the registered notification mailed to the offset operators (Amerada Hess and Sun Oil).


