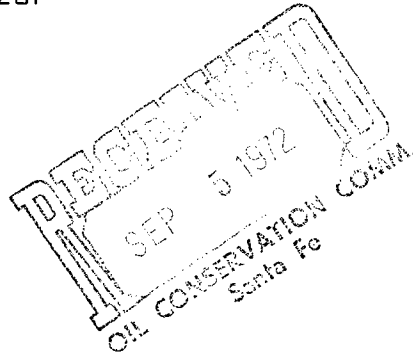

Gentlemen:

The above captioned well was drilled at a standard location for an oil well in the Bluit San Andres Associated field. This location was 660' FNL and 1980' FWL of Section 24, T8S, R37E. The well was drilled to a total depth of 4830' and completed as a San Andres oil well.

Production generally declined until the well was barely economical. In August of this year, the well was re-completed from the P1 zone of the San Andres from perforations 4618 to 4691. After fracturing, the well will be potentialized as a gas well with a CAOF of approximately two million cubic feet per day.

Upon original completion, 80 acres was assigned to this standard location. Now that the well will be re-classified as a gas well, it is requested that administrative approval be given for this location.

The W/2 of Section 24 comprising 320 acres will be assigned as a pro-ration unit. Communitization papers are now being drawn to permit this allocation. Upon approval, a form C-102 making this dedication will be submitted.

A Gas Contract and Connection are awaiting this approval.

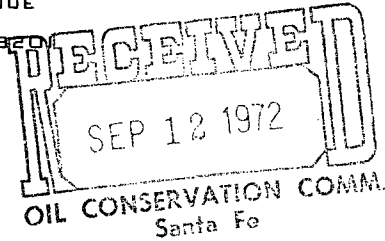

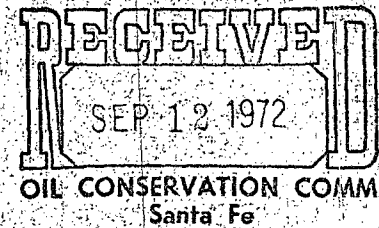
