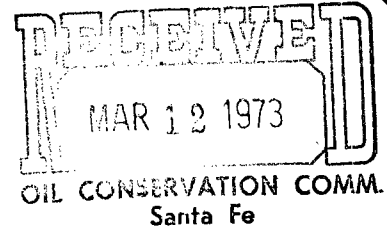

Gentlemen:

Atlantic Richfield Company respectfully requests your approval to change a non-standard proration unit to a standard proration unit, with an unorthodox well location, in the Blinebry Gas Pool. The subject well presently produces from a 120-acre non-standard gas proration unit comprising the E/2, SW/4, and the NW/4, SW/4 of Section 29, T-21S, R-37E. The SW/4, SW/4 of this section was dedicated to the H. S. Turner No. 4, a Blinebry Oil Well, which has been plugged and abandoned. The W. H. Turner No. 1 is presently the only well producing from the Blinebry formation in this 160 acres. Therefore, Atlantic Richfield requests approval for a 160-acre standard gas proration unit in the Blinebry Gas Pool. This unit will comprise the SW/4 of Section 29, T-21S, R-37E as shown on the attached plat. The W. H. Turner No. 1 is in an unorthodox location, being 990' FWL and 2310' PSL of Section 29. Mr. Dan Nutter of your Santa Fe office indicated to us that approval for this may be given administratively in Hobbs since it had been approved previously for the 120-acre non-standard unit.

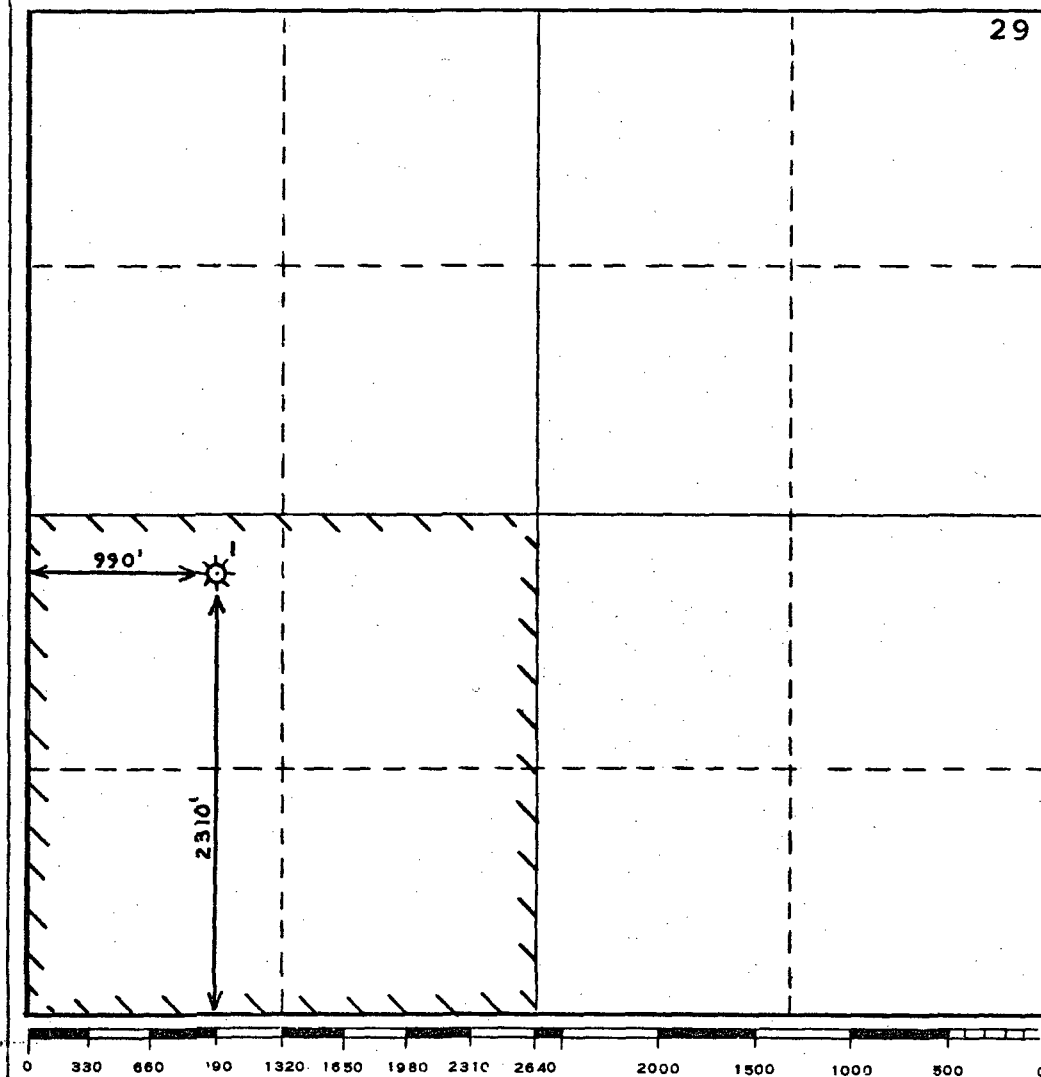
