Reference is made to the following: (i) your application dated September 19, 2000; and (ii) the records of the New Mexico Oil Conservation Division ("Division") in Santa Fe: all concerning Merrion Oil & Gas Corporation's ("Merrion") request for a replacement Fruitland Sand/Pictured Cliffs gas well to be drilled at an unorthodox location within a standard 160-acre gas spacing and proration unit comprising the SW/4 of Section 35, Township 27 North, Range 13 West, NMPM, WAW Fruitland Sand-Pictured Cliffs Pool, San Juan County, New Mexico.

Initial development of WAW Fruitland Sand-Pictured Cliffs Pool gas production within the subject 160-acre gas spacing and proration unit commenced in 1978 when J. Gregory Merrion and Robert L. Bayless drilled the Hi Roll Well No. 2 (API No. 30-045-23033) at an unorthodox gas well location (approved by Division Administrative Order NSL-961 dated June 19, 1978) 2000 feet from the South line and 1850 feet from the West line (Unit K) of Section 35.

This application has been duly filed under the provisions of Division Rule 104.F, revised by Division Order No. R-11231, issued by the New Mexico Oil Conservation Commission in Case No. 12119 on August 12, 1999.

It is our understanding that the Hi Roll Well No. 2 is currently shut-in and that Merrion intends to plug and abandon the well.

By the authority granted me under the provisions of Division Rule 104.F (2), the following described well to be drilled as a replacement Fruitland Sand/Pictured Cliffs gas well on this 160-acre gas spacing and proration unit at an unorthodox location is hereby approved:
