Enclosed is an original Form C-107 A (Application for Downhole Commingling) for the well mentioned above.

Cimarex recently drilled the Black Magic 6 Com No. 1 to a TD of 12075.' Our analysis of the logs indicates 2 pay intervals: Atoka from 10418'-10454' and a Morrow from 11150'-11225.'


We will isolate each zone during completion to produce a well test that will be used to establish a percentage split.

It is anticipated that the reservoir pressure from these two zones will be compatible and the resulting volumes would not warrant a casing/tubing dual completion.

All royalty, overriding royalty, and working interest owners are identical in the two zones, and will not be harmed by an Atoka/Morrow commingling.


